Shri R.S. Gill, IFS, PCCF & HoFF, Meghalaya chaired the meeting being the Chairperson of the Executive Committee. At the outset, the Chairman welcomed all the members of the 'Executive Committee' and highlighted the importance of this meeting. Thereafter, he requested the CEO CAMPA to initiate discussion as per the agenda. The CEO briefed the members of the Committee on the proposed Annual Plan of Operation (APO) for the financial year 2024-25 through a Power Point presentation and placed the draft APO before the Committee for their consideration and approval.

The item-wise detailed presentation on the proposed activities contained in the APO for the financial year 2024-25 was made to the Committee. The detailed abstract of components are as follows:-

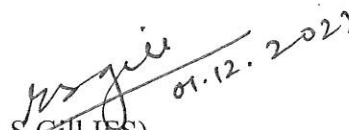
Deliberations: After thorough deliberation the following decisions were taken: -

1. In future, the detailed APOs should also be circulated to all members along with the agenda notice.
2. 3rd party Monitoring & Evaluation report shall be placed before the Committee and the survival percentage of all plantations recorded by the concerned party needs to be highlighted.
3. All implementing agencies are required to provide the status and survival percentage of all plantations where maintenance work has been proposed under APO 2024-25.
4. It needs to be communicated to the State Government that CAMPA funds need to be dealt separately and when the APO is approved by the National Authority, the release of funds should not be delayed. The State Government may be apprised that CAMPA related scheme being a time-bound scheme, funds need to be released on time to enable taking up planting of seedlings and other maintenance work on schedule and within the planting season.

5. The proposal of the CEO for surrender of unspent balance for the Annual Plan of Operation 2021-22 was approved after briefing of the CEO on the matter.
6. It was also informed by the CEO that because many States are seeking funds for purchasing vehicles for frontline staff and the National CAMPA have taken a decision in its 3rd General Body meeting of the National Authority held on 15th February, 2023 to approve the proposal of purchase of vehicle (Rule 5(4) of CAF Rules 2018) and have prepared guidelines to this effect which has also been received by Meghalaya State CAMPA. It was decided that the guidelines for purchase of vehicles shall be circulated by the CEO to the Wing heads for their views and opinions after receipt of which the CEO shall summarize them and communicate them to the National Authority.
7. The PCCF (Working Plan, Research & Training and District Council Affairs) raised the issue of project proposal for establishment of a supply chain for assured supply of seeds and other plant propagules of superior genetic makeup at a total estimated outlay of Rs. 21.39 crores. No further discussion on the matter was entertained because the said proposal was not part of the agenda discussed for the APOs, and hence could be taken up later.

After a thorough deliberation, the Executive Committee approved all the Non-NPV and NPV activities incorporated in the APO for the year 2024-25 amounting to ₹ 24,69,34,712 (Rupees Twenty-four crores sixty-nine lakhs thirty-four thousand seven hundred and twelve) only and recommended placing the same before the Steering Committee of the CAMPA for their kind approval. Executive Committee recorded the dissent against approving the APO, which was raised by only one of the Executive Members viz., PCCF (Working Plan, Research & Training and District Council affairs).

The meeting was concluded with a *vote of thanks* from the Chair.

A) BRIEF HISTORY AND PAST PERFORMANCE BRIEF DESCRIPTION OF FORESTS AND FORESTRY SECTOR IN THE STATE: -

Meghalaya is a State where Land Tenure System is totally different from the rest of the country. Here, land mostly belongs to the private individuals, clans and communities. Out of a total geographical area of 22,429 Sq. Km, the recorded forest area owned by State Forest Department is only 1125 Sq. Km which constitutes about 5% of the geographical area. The other forest areas of about 15921 Sq Km, including those owned by individuals, clans and communities are under the control of the Autonomous District Councils. As per the 'India State of Forest Report 2021' published by the Forest Survey of India, the total forest cover of Meghalaya is 17046.07sq km. Though 76.00% of her geographical area is under forests, the dense forested area is small. About 2.50% of her geographical area is categorized as very dense forests and 40.84% as moderately dense forest. The rest is open forest.

Meghalaya is among the few states in the country which can be proud of its abundances of natural forest wealth spanning across sizeable large part of its geographical area, much higher than the national average. The State is gifted with the treasure of wide range of flora and fauna, some of which are unique and endemic to this region. This profuse natural treasure, however, also poses a commensurate range of management challenges. Although latest reports show that around 76% of the geographical area is under forest and tree cover, only about 5% of the total geographical area is under direct control and management of the State Government. The rest of the forests, owing to the unique land tenure system of the State, are owned by communities, clans or private individuals, and are managed by the three Autonomous District Councils in Garo Hills, Khasi Hills and Jaintia Hills, in a manner which cannot be termed as scientific management. This has caused, with passage of time substantial loss of forest cover in the State. The Hon'ble Supreme Court, in the matter of WP (C) 202 of 1995, took cognizance of the situation and directed that all the forests, irrespective of ownership, would come under scientific management as per Working Schemes approved by Government of India.

Conservation of Forests and vegetation cover is also highly significant in view of its role in maintaining water cycle. They help the soil in absorbing a sizable proportion of the precipitation so that the entire quantity of water that falls on any area of the earth's surface does not flow down rapidly only along the surface but also replenishes the subterranean aquifers from which, it comes out through natural springs, wells and tube wells. The moisture in the subsoil is absorbed by the roots of trees and plants, and after passing through the stem and branches of trees, it goes back into the atmosphere which results in an increase in the rainfall, particularly rainfall caused by local factors. Thus, forests are the best protective agents

for soil and water conservation. As most part of Meghalaya is a catchment for various major and minor rivers, streams in the State, conservation of forest cover in this region is essential from the point of view of water conservation as well.

While the directives of the Apex Court are in the process of being implemented, the need for having a different target-oriented time-bound approach to forest management is strongly felt. In this backdrop, the State CAMPA proposes to identify core objectives, set quantifiable targets to meet the core issues, and achieve these targets within the stipulated timelines.

Implementation of Social Forestry Programme in the State of Meghalaya started during the year 1981 with the creation of a separate Social Forestry Circle. The main task of the Social Forestry Circle was to carry out afforestation programmes in the areas outside the Government Control Forest areas which include the Reserved Forests, Protected Forests, Wild-life Sanctuaries and National Parks. The task of the Social Forestry Circle was therefore, to afforest the degraded areas falling outside the jurisdiction of the State Forest Department. This was achieved by negotiating with the Land owners, consisting of private individuals, Clan members and Community members to arrive at a consensus, execution of an agreement and followed by the actual afforestation of the area. Therefore, it can be said that the concept of Joint Forest Management was started in Meghalaya right from the inception of the Social Forestry Circle though the same was not officially called as the JFM.

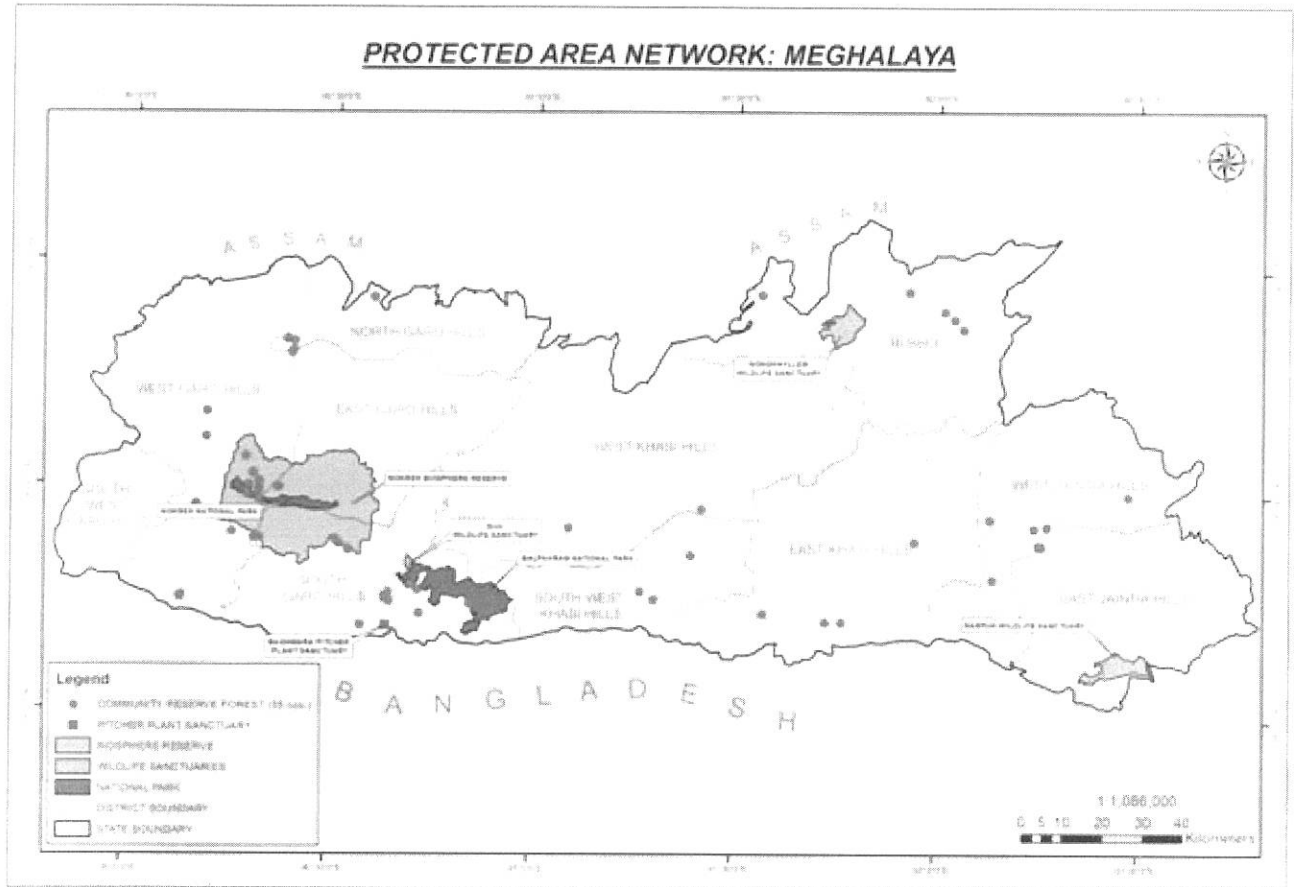

Certain wildlife bearing areas of significance, comprising of the buffers of PAs, viable wildlife habitats and important corridors which are not under direct government control, have been identified for management as biosphere reserves and elephant reserves as shown below. In these areas public co-operation and participation in conservation programmes are imperative for achievement of management objectives.

NOKREK NATIONAL PARK

Area :47.48 Sq.Kms

Location: Spread in East Garo Hills and West Garo Hills, about 15 km distance from Williamnagar and about 45 km distance from Tura

Gazette Notification and Date: No.FOR.23/86/204,Dt.29-11-1986

Conservation value: UNESCO added Nokrek National park to its list of Biosphere Reserves in May 2009. Nokrek Biosphere Reserve covers an area of 820 Sq.Kms. The Reserve is one of the least disturbed forest tract of Sub-Himalayan range. The park is home to a variety of animals, birds and pheasants, beside some rare and endemic flora. Important animals found here are Indian Elephant, Hoolock Gibbons, Capped Langur, Stump Tailed Macaque, Clouded Leopard, Leopard, Gaur, Sambar, Barking Deer, Himalayan Black Bear, Sloth Bear. Many species of birds can also be spotted here and the national park is considered to be an important bird area and an ideal spot for bird watchers. *Citrus indica* which is mother of all citrus fruit in the world is endemic to this place and the locals call it by name *memangnarang* ('orange of the spirits'). Nokrek is also believed to be the home of *Mande Burung* (jungle man or ape man) and reported cases of sightings found in and around the villages of Nokrek.

BALPAKRAM NATIONAL PARK – RESTING PLACE OF SPIRITS OF DEAD

Area : 220 Sq.km.

Gazette Notification & Date: No.FOR.103/34/354,Dt.15-2-1986

Location: Located in South Garo Hills, 293 km from Guwahati, about 166 km from Tura and 62 km from Baghmara

Best time to visit: November to March.

The literal meaning of Balpakram is the “land of perpetual winds”. Balpakram is famous for its forest covered canyon-cum-gorge and numerous geo-physical formations, all of which makes the place a land of mystery. It is often compared to the Grand Canyon National Park of the United States of America, to the local Garo inhabitants, Balpakram is the abode of the spirits of the dead. It is believed that here, the spirits of the dead dwell temporarily before embarking on the final journey. The park consists of a succession of hills and valley with constant abrupt variation in altitude, aspect and gradient. The deepest gorge is the Mahadeo gorge, locally known as Kundulop with drop of over 600 meters. The most prominent physical feature of the park is the bullock hump shaped Chitmag peak or Kailash, rising to a height of about 1023 meters.

Mystery of Balpakram

Balpakram has many mysterious and unnatural phenomena that cannot be satisfactorily explained by modern science and logic. Some of the mysterious sites are Boldakmatchukaram, Chitmag peak, Matchru, Arengpatal, Goncho Dare, Dikkini ring, RongsaljongAgal, RongsobokRongkol. Indeed, Balpakram is so steeped in myths that even the Hindus believe that it is a sacred place. They believe that when Laxman was seriously injured in the war, a very rare lifesaving herb was required, Lord Hanuman found it here but not knowing which to take, broke the top of the hill and carried it away. The missing portion of that hill became a deep awning canyon.

Conservation value: Stretching between an altitudinal zonation of 100 meters to well over 1027 meters, Balpakram National Park harbours a rich and diverse gene pool. It is home to many rare and endemic animals. The National Park is home to Elephants, Tigers, Sambar, Barking deer, Gaur, Clouded leopard, Red panda, Black bear.

Tour Time: The Park is open to visitor from 1st of November to 31st of May every year. The Park is open to visitors from 5 A.M. to 4 P.M. from the month of November-February and 5 A.M. to 6 P.M. from March-May.

NONGKHYLLEM WILDLIFE SANCTUARY

Area :29.00 Sq.Kms

Location: Ri-Bhoi District, about 53 km distance from Shillong and about 51 km distance from Dispur.

Gazette Notification and Date: No.FOR.25/81/5,Dt.25-03-1981

Conservation value:

The Sanctuary falls in the Eastern Himalayan Global bio-diversity hot spot. This area is rich in Floral and Faunal wealth. It has attracted the the attention of wildlife enthusiasts and research scholars from all over the country. J.Joseph, who compiled the flora of Nongpoh and its vicinity in 1982, noted about 1036 taxa of vegetation belonging to 639 genera of 159 families in a study area of about 200 Sq.Kms. He stated that a unit of the South Indian Forests of the Western Ghats, another bio-diversity hot spot, harbors less number of species as compared to these forests.

The first ever bird survey carried out by Shri Anwarruddin Choudhury of the Rhino Foundation of India in this Sanctuary from April, 1996 to October,1998, recorded over 400+ species of bird. The survey revealed the presence of endangered species such as the Rufous Necked Hornbill.

The area harbors over 50 species of mammals and 25 species of reptiles. Out of 140 species of mammals listed in Schedule I of the Wild Life (Protection) Act1972, about 30 species are found in this Sanctuary.

NARPUH WILDLIFE SANCTUARY

Area :59.9 Sq.Kms

Location: East Jaintia Hills District, about 78 kms distance from Jowai and about 155 kms distance from Shillong.

Gazette Notification and Date: No.FOR.128/2013/20,Dt.10-06-2014

Conservation value:

The Narpuh Wildlife Sanctuary is the only large tract of pristine forest left in both the East & West Jaintia hills District as well as the eastern part of Meghalaya. This area has some of the tallest evergreen and semi-evergreen forest left in Meghalaya. The Sanctuary is also home to many Schedule I species such as Hoolock gibbon, Serow, Slow loris, Pied Horn bill, Leopard etc.

The favorable climate with rich vegetation offers a good habitation of the area to support a wide variety of wild, endangered Flora and Fauna, the Sanctuary is endowed with a rich diversity and abundance of wildlife. Till recently only few studies has been conducted to explore the Fauna diversity in the Sanctuary, the studies conducted so far are as follows:-

- In the year 1996-98, a study was conducted by the Zoological Survey of India, the first at such survey for the District, as per the report there are 25 species of birds, 61 species of mammals, 16 species of Reptiles, 74 species of fishes and 15 species of Amphibians.
- Dr.Anwarruddin Choudhury in the year 1999 has submitted the interim report of wildlife survey in Jaintia Hills, according to which there are more than 120 species of mammals.
- In 2016-2017, the Department with Dr.RajkamalGoswami from Ashoka Trust for Research in Ecology & the Environment had carried out fauna survey in the Sanctuary using camera trap, as per the study 92 species of birds, 35 species of mammals & 199 species of butterfly were recorded.

Birds : About 92 species have been recorded so far. Among the noteworthy species recorded so far includes, Oriental Pied Hornbill, Giant or Great Pied Hornbill, Spangled Drongo, Rufous-throated Partridgeetc.

Butterflies :- The Sanctuary has a number of small nullas, streams etc. which harbor a rich variety of Butterflies, Dr.RajkamalGoswami during his studies in the Sanctuary has recorded around 91 species of butterflies. Some of the butterflies are very rarewhich can be located only

in the Sanctuary. It can be stated that the Sanctuary is exceptionally rich in butterfly diversity.

Reptiles :-The Asian Leaf Tule(*Cyclemis dentate*), a poorly known testudine was recorded in Prang and Lukha rivers. The Copper headed Trinket Snake, Red-necked Keelback, monitor lizard and species of frog(*Kaloula spp.*) have been recorded from the region. The Common *Varanus bengalensis*, water monitors, Rock Python, King Cobra, Common Cobra, Banded krait, Common krait, Common vine snake, Green pit viper and reticulated python have also been recorded.

SIJU WILDLIFE SANCTUARY

Area :5.18 Sq.Kms

Location: South Garo Hills District, about 45 kms distance from Baghmara, 160 kms from Tura and about 475 kms distance from Shillong.

Gazette Notification and Date: No.MFG.66/4,Dt.30-03-1979

Conservation value:

The oldest and the first Wildlife Sanctuary of Meghalaya located in the remote Garo Hills region of Meghalaya. Sharing its border on the Eastern part with the Balpakram National Park and blessed by the longest river of Meghalaya, the Simsang, as neighbor on the Western part, is home to many endemic rare flora and fauna. It also shares its border with the Balpakram-Baghmara and Siju-Rewak elephant Corridors within its Southern periphery. Siju Wildlife Sanctuary came into existence in 1979. Earlier the area was declared Reserved Forest by the Lieutenant-Governor of East Bengal and Assam in 1906. The origin of the name of Siju Wildlife Sanctuary (SWLS) could be tracked back from its location in the village named "Siju". Thus the name "Siju Wildlife Sanctuary". Siju is a fast growing village dominated by Garo subtribe known as "Attong". Although, the Sanctuary is very small in size - covering only 5.18 Sq.Kms, but its flora composition is of primary origin. many wild animals such as Elephants, Barking Deer, Sambar Deer, Wild Boar, Tiger, Clouded Leopard etc. are well represented in the Sanctuary. At least 5 species of primates - Hoolock Gibbon, Stumped Tailed Macaque, Langurs, Slow Loris and Rhesus Macaque are recorded. Popularly regarded as the "Bird Sanctuary", the area offer many enchanting migratory birds encounters inside the Sanctuary such as Siberian Ducks, Spoonbill, etc.

BAGHMARA PITCHER PLANT SANCTUARY

Area : 2.7 hectares

Location: South Garo Hills District, Baghmara about 112 kms distance from Tura and about 332 kms distance from Guwahati railway station.

Gazette Notification and Date: No.FOR.79/84/5, Dt.24-05-1984

Conservation value:

The Baghmara Pitcher Plant Sanctuary is named after the location of the Sanctuary and Pitcher plant, *Nepenthes Khasiana* a rare insectivorous plant which is being protected and conserved in the Sanctuary. The Pitcher plant is locally known as "Me'mang-Koksi" (Me'mang = Ghost; Koksi = Basket). The locals, Garos regard it as a sacred plant or the Ghost basket. *Nepenthes Khasiana* is the only endemic species of genus *Nepenthes* that occurs in India, and in Meghalaya State. Also, the species is the only Pitcher Plant found in India. The species and its habitat are unique, as it occurs with an isolated population in Meghalaya. It can be said that the species represents ancient endemic remnants of older floras which usually occur in landmasses of geological antiquity (Palaeoendemic) (Bramwell, 1972). Hence, the species is of great biological interest. Its rare status gives it a very high ecological importance. The Baghmara Pitcher Plant Sanctuary (BPPS) is the only Sanctuary in Meghalaya where *in-situ* conservation of Pitcher Plant is being carried out. Although the area is very limited, plenty of Pitcher plant grows luxuriantly. The very objective of the establishment of Baghmara Pitcher Plant Sanctuary is to protect and preserve this rare, endemic and threatened in nature for generations. The vegetations of the Sanctuary provides home to small animals such as squirrels, foxes, mongoose, lizards, snakes etc. in the heart of the town. The Sanctuary also protects soil erosion and provide water to section of the surrounding villages. Besides, Pitcher Plant, many endemic flora and fauna are found in Baghmara-Balpakram Landscape. In fact the area has high level of endemism. The Pitcher Plant (*Nepenthes Khasiana*) and Drosera etc. are endemic species. These have the best chance of survival in Baghmara-Balpakram landscape.

NOKREK BIOSPHERE RESERVE

Area :820 Sq.Kms

Core Zone :47.48 Sq.Kms

Buffer Zone :227.92 Sq.Kms

Transition Zone :544.60 Sq.Kms

Location: Nokrek Biosphere Reserve extends to three districts namely West Garo Hills, East Garo Hills and South Garo Hills District.

Gazette Notification and Date: Notified by the ministry of Environment & Forests on 01-09-1988.

Conservation value:

Nokrek Biosphere Reserve is the First Biosphere Reserve in the North-East India to be designated for inclusion in the World Network of Biosphere Reserve of Man and the Biosphere Programme, UNESCO on 26-05-2009. Nokrek Biosphere Reserve is a rich gene pool of citrus species, especially the *Citrus indica Tanaka* and other related cultivars. Apart from several other species of wild animals such as - Himalayan Black Bear, Slow Loris, Guar, Clouded Leopard etc., Nokrek Biosphere Reserve is home to a large population of Hoolock gibbon, the only ape found in India. It is catchment area of several streams, including the streams providing drinking water to Tura and other towns.

GARO HILLS ELEPHANT RESERVE

Area :3500 Sq.Kms (approx.)

Core Zone :533.892 Sq.Kms (approx.)

Buffer Zone :2900 Sq.Kms (approx.)

Location: Parts of the Civil Districts of East Garo Hills, West Garo Hills and South Garo Hills comprising Balpakram National Park, Siju Wildlife Sanctuary, Rewak Reserved Forest, Emangre Reserved Forest, Nokrek National Park, Baghmara Reserved Forest, Angratoli Reserved Forest, Rongrangiri Reserved Forest, Tura Peak Reserved Forest and all the Clan/Community lands comprising them.

Gazette Notification and Date: No.FOR.132/2000/97 dated 31-10-2001

Conservation value:

The State of Meghalaya has a sizeable number of elephant populations. These are not contained within the Protected Area network which are under the direct control of the State Government. A significant population of elephants resides outside the Protected Area network. The elephant because of their long ranging movement, need for shelter and food requirement, move from one block of forest to another which lie in fragmented form. The area outside the Protected

Area network is interspersed with human habitation. It was therefore considered essential to define a management unit which acknowledges presence of human being along with the elephant, prescribing management practice synergizing the need of both the components. The thrust of management in such areas is eco-development works to improve economic status of human being, anti-depredation activities to reduce man animal conflict and habitat improvement programme to divert the movement of elephants. One such Elephant Reserves in the Garo Hills region under the Centrally Sector Scheme of Project Elephant has already been notified vide Government of Meghalaya Notification Number 132/2000/97 dated 31st October 2001 measuring a total area of 3500 sq kms approximately.

ENVIRONMENT & ECOLOGY

The Govt. of Meghalaya renamed the 'Forest Department' as the 'Forest & Environment Department' in the year 1991 and transferred Environment Planning Cell from Urban Affairs Department on 15th March, 1991. It was subsequently again renamed in 2014 as 'Department of Forest & Environment & Climate Change'. In the year 2015, the administrative control of the State Pollution Control Board was transferred to this Department. In August 2015, the Govt. of Meghalaya has notified the o/o the Addl. PCCF (SF & E) as the secretariat of the newly re-constituted SEIAA (State Environment Impact Assessment Authority) and also made the CCF (SF & E) as its ex-officio Member Secretary. Currently, the staff of 'Environment Cell' has been assisting the SEIAA, in addition to other duties.

The Social Forestry & Environment Wing concentrated its effort on raising forest nursery, roadside plantation, block plantation on community and private land with an objective to ameliorate environmental degradations. Thus to a great extent such afforestation measures helped to maintain overall satisfactory forest cover for the State as may be seen in the India State of Forest Report.

C) Forestry and other related schemes and activities carried out therein in the state in previous years from the fund received under other schemes of the Government in tabular form National Afforestation Programme: -

Meghalaya notified the constitution of Forest Development Agency and application of the Joint Forest Management principles on 9th Sept 2003. The Forest & Environment Department followed up the said notification and registered 9 FDAs constituted in the seven (7) Social Forestry Divisions, one (1) in Territorial Division (Jaintia Hills Territorial Division) and one (1) in Wildlife Division (Khasi Hills Wildlife Division). The concerned Conservator of Forests (Social Forestry) registered the JFMCs.

These Forest Development Agencies have been constituted for the purpose of implementation of afforestation programme particularly the National Afforestation Programme (NAP). Funds under the NAP are channelized through the Forest Development Agencies. The actual implementation of NAP is done through the Joint Forest Management Committees at the village level. The effective implementation of the JFM programme will go a long way in generating gainful employment opportunities for rural people, reducing the incidence of poverty, and subsequently leading to higher level of income and employment. Hence people's participation is a key to improvement of forest cover and sustainable management of natural resources which is one of the strongest means of development for masses.

During the year 2014-15, proposal submitted was 5395 hectares for Advance works, 3000 ha for creation and 11648 hectares for maintenance in which the MoEF& CC sanctioned only for creation and maintenance. No fund was sanction for Advance works during the year. The amount released was Rs.361 lakhs only out of Rs.500 lakhs being the allocation approved and fixed by MoEF& CC (NAEB).

During the year 2015-16, no proposal under creation was submitted since fund under Advance works was not sanctioned during 2014-15. Only maintenance for 9910 hectares was proposed and sanctioned by MoEF& CC (NAEB) for maintenance of 8482 hectares only. The amount released vide Government of India F.No.MoEF&CC (NAEB) 1-4/205-B-IV, dated 22.03.2016 was Rs. 1,34,98,500/- (Rupees one crore thirty four lakhs ninety eight thousand and five hundred only).

During the year 2016-17, proposal was submitted for 3037 hectares for Advance work and 4552 hectares for maintenance of old plantations. **The MoEF& CC (NAEB) did not sanction any work programme during 2016-17.**

During the year 2017-18, proposal was submitted for 2726 hectares for Advance woks and 1584 hectares for maintenance. The MoEF& CC (NAEB) sanctioned only 1584 hectares for undertaking maintenance works and committed liabilities for 2015-16 (balance amount for

maintenance during 2015-16 since 2nd instalment was not released during the year). The amount released vide Government of India F.No.MoEF&CC (NAEB): 1-4/2017-B-IV, dated 28.02.2018 was Rs. 1,64,62,000/- (Rupees one crore sixtyfour lakh and sixty two thousand only). The remaining amount of Rs 73.85 lakhs (Rupees Seventy three lakhs and eighty five thousand) only being pending payments of previous year was released by MoEF& CC vide letter F. No. MoEF&CC(NAEB): 1-4/2018-B-IV, dated 15.11.2018.

The MoEF& CC vide letter No. MoEF& CC (NAEB):25-1-1/99-B-II-Part Dated 01/04/2016 stated that the fund sharing pattern will be Central: State :: 90 : 10 for the North Eastern States. Further, the MoEF& CC vide letter No. MoEF& CC (NAEB):1-2/2017-B-1 Dated 30/01/2018 communicated for merger of NAP under NAEB and Desertification Cell (DC) with National Mission for a Green India (GIM). Annual Plan of Operation for 2018-19 and 2019-20 were also prepared and submitted to NAEB, MoEF& CC but no fund was provided by GOI for Meghalaya.

As on March 2020, there are 9 FDAs in the State; 7(seven) FDAs under Social Forestry Wing, 1(one) FDA under Jaintia Hills Territorial Division and 1(one) FDA under Khasi Hills Wildlife Division. Altogether, there are 366 JFMCs under 9 FDAs implementing the National Afforestation Programme (NAP), as shown below:-

Other afforestation programmes with participation of private sectors undertaken by the Forest Department include Schemes sanctioned under Compensatory Afforestation or CAMPA being implemented in the entire state. The last fund from Finance Commission Grant released to Forest & Environment Department, Meghalaya was during 2014-15. From the year 2015-16 onwards **no fund** under Finance Commission Grant was released for creation and maintenance of plantations to the State Forest & Environment Department, Meghalaya.

Since no fund was provided under NAP, Green India Mission (GIM) and FC Grant/Award for raising plantation for the last few years, hence, CAMPA fund is the only source of fund for undertaking forestry related activities including CA (non-NPV) and NPV activities in the State.

CLIMATE CHANGE, RESEARCH & TRAINING WING

The Research & Training Wing of the Department which has been rechristened as Climate Change, Research & Training after the addition of the Climate Change subject to its sphere of responsibilities, is basically arm of the Department addressing matters of Forestry research, Forest resource assessment, capacity building and climate change. There are five divisions under the jurisdiction of the wing viz Working Plan Division, Silviculture Division, Training Division, Forest Utilization Division and Forest Resources Survey Division. The wing is headed by the Principal Chief Conservator of Forests (CC, R & T) who is assisted by the Additional Principal Chief Conservator of Forests (CC, R & T), Conservator of Forests (CC, R & T) and the Deputy Conservator of Forests in the Head Quarter and the Divisional Forest Officers at the Divisional level. Each Division is mandated with the following works: -

1. Working Plan Division:

- (i) To write the working plans for all the Reserve Forests and the Protected forests for their scientific management.
- (ii) To write and prepare the working schemes for all the community, privately owned forests and the forests under the jurisdiction and management of the Autonomous District Councils.

2. Silviculture Division:

- (i) To take up scientific studies of the endemic plants, endangered species of flora for their scientific management.
- (ii) Taking up propagation of plants through Tissue culture laboratory, High tech plant nurseries and prepare protocols on the methodology for raising nursery and plantations.
- (iii) Documentation and Publication of books on specific plant species, their propagation and scientific silvicultural operation.
- (iv) To identify areas for establishment of seed orchards and plus trees,

3. Training Division:

This Division caters to the need of imparting Training of Field Staff of the rank of Forester and Forest Guard on Forest Management, Wildlife Management and Nursery Techniques at Meghalaya Forest Training School, Williamnagar, Baiza. The certificate course is of I(one) year duration. This division also undertake the short-term training courses for the Ministerial staff, Forest Guards, Forester & Range Forest Officer on various aspects.

Functions of Training Division

The Training Division headed by the Divisional Forest Officer at Shillong is mandated with: -

- (i) Supervising the Meghalaya Forest Training School Baiza in imparting Professional Training in Forestry and allied subjects to the Forester and Forest Guards in the State.
- (ii) Conducting Short Term Training courses for Ministerial staff on Forests accounts, establishment matter, Office procedure etc.
- (iii) Conducting Short Term Training courses for Frontline staff on GPS, Enforcement of Acts and Rules, Forest Fire control, Nursery techniques etc.
- (iv) Conducting Refresher Training courses for Forest Officials.
- (v) Coordinating the visit of batches of IFS (Probationers), MCT Batches, Trainees of State Forest Academy and Central Forest Academy to the State.
- (vi) Coordinating the attachment of B.Sc. Forestry students from various Universities in State Forest Department.
- (vii) Any other works assigned by higher authority.

4. Forest Utilization Division:

This division was mandated to regulate sale and transportation of Railway sleepers in the past. However, now that railway sleeper project is no longer in operation, the Division is taking up other works like raising of Bamboo plantations etc

5. Forest Resources Survey Division:

This division is mandated to take up boundary survey, growing stock estimation and enumeration of plant species in the sacred groves of Meghalaya. It is also mandated to take up survey of trade of Minor forest produce and other forest resources in the state.
