Please find enclosed the Annual Plan of Operation (APO) of Jharkhand CAMPA State Authority for the year 2022-23. The APO has been approved by the State level Steering Committee of Jharkhand CAMPA State Authority in its meeting held on 31.01.2022 under the chairmanship. of Chief Secretary, Jharkhand. A copy of the proceedings of the meeting and two volumes (volume I and volume II) of APO 2022-23 are enclosed herewith.

2. Total amount of APO 2022-23 as approved by the Steering Committee is for Rs. 794.77 crore (Rupees Seven hundred ninety four crore and seventy seven lakh seven thousand and four hundred only).

3. The Certificate regarding the adoption of APO 2022-23 by the State Authority is annexed at page no. 178 of the volume I of APO.

4. Following are some relevant information regarding the aforementioned APO:

- Outlay under Rule 5(2) (Not less than 80% of NPV) = Rs. 40681.818 lakh (84.12%)
- Outlay under Rule 5(3) (Not more than 20% of NPV) =Rs. 7680.577 lakh (15.88%)
- Outlay under Rule 6(a) (Not less than 60% of Interest) = Rs. 1000.00 lakh (83.33%)
- Outlay under Rule 6(b) (Not more than 40% of Interest) = Rs. 200.00 lakh (16.67%)



Meeting of Steering Committee of State Authority of Jharkhand CAMPA was held on 31.01.2022 under the chairmanship of Chief Secretary, Jharkhand.

2. List of members present is enclosed (**Annexure- I**).
3. The agenda items were taken up for discussion and following decisions were taken:-

**Agenda No. 1:**

The proceedings of the meeting of the Steering Committee held on 17.05.2021 were confirmed.

**Agenda No. 2**

**Progress of Financial Year 2021-22**

Approval of Rs. 469.55 crore for the Jharkhand CAMPA APO 2020-21 was granted by the State level Steering Committee in its meeting dated 17.05.2021. It was then sent to National Authority, CAMPA, MoEF&CC, Govt. of India, for its approval. The Executive Committee, National Authority, CAMPA has so far granted the approval of Rs. 437.60 crore for the CAMPA APO 2021-22. The State Govt. has allotted the budget of Rs. 219.25 crore for implementation of CAMPA APO activities. Expenditure of Rs. 123.73 crore has been incurred by the implementing units towards activities under the APO. The works are under progress in CA, NPV, CAT Plan and IWMP.

The Committee took note of the progress of various schemes of APO 2021-22 up to 28<sup>th</sup> January, 2021.

**Agenda No. 3**

**Annual Plan of Operations for Financial Year 2022-23**

For the year 2022-23, APO of Rs. 79477.074 Lakh has been prepared based on proposals received from field formations and in accordance with the provisions of Compensatory Afforestation Fund Rules, 2018 and CAF Act 2016.

The APO has been arranged in two volumes. Volume I and Volume II.

Volume I contains Form XII of the APO having the entire details of budget for 2022-23 with relevant annexures. Volume II contains relevant estimates of work and important letters for inclusion of some activity during preparation of APO.

The proposed APO for 2022-23 in Volume I consists of six parts:

- Part-1** contains site-specific activities, both on going and new ones, pertaining to 'Compensatory Afforestation' and compliance of other conditions imposed by Govt. of India while according forest clearance under FC Act, 1980.
- Part-2** contains activities proposed under 'Catchment Area Treatment Plan'.
- Part-3** contains proposals under 'Integrated Wildlife Management Plan'.
- Part-4** contains activities, both ongoing and new ones, as permissible under 'Net Present Value' (NPV).
- Part-5** contains 'Utilization of interest' accrued on deposits in State Fund, and
- Part-6** contains activities under 'Others' component.

The APO contains physical and financial targets proposed under different categories, major works under CA/PCA component being completion work in 6327.687ha, maintenance work in 18288.266 ha and advance work in 8101.695 ha under Block Plantations, besides other targets and condition compliance works. Highest priority has been accorded to speed up clearing of backlog of compensatory afforestation. The APO also contains proposals under Catchment Area Treatment (CAT) Plan and Integrated Wildlife Management Plan (IWMP) for various forest divisions.

Further, under NPV component, Silvicultural operation scheme second year work in 11,445.00 ha, block plantation second year work in 2900.000 ha, maintenance work of block plantations in 3491.50 ha, maintenance of Silvicultural operation scheme has been proposed further in 14831.530 ha. First year work for Silvicultural operation scheme is proposed in 14850.000 ha, and first year work for block plantation year is proposed in 14400.000 ha. Besides other work further, the proposal contains maintenance of permanent and Hi-Tech nurseries, infrastructure facilities for frontline staff, promotion of solar energy and energy saving devices, evaluation of CAMPA works, wildlife habitat improvement and related works etc.

Ministry of Environment, Forest & Climate Change, Govt. of India had transferred an amount of Rs. 4,158 crore vide its letter no. 11-100/2015-FC/NA dated 29.08.2019 and letter no. 11-100/2015-FC/NA dated 03.11.2021 towards the State share of Jharkhand. As against the proposed APO of Rs. 79477.074 Lakh, implementation of various activities will be

limited to the amount sanctioned by the State Government, Jharkhand after the final approval of National CAMPA, Govt. of India.

The Committee members deliberated in details on the APO proposals and the following decisions were taken -

1. The Committee discussed on the stipulated target of CA/PCA and their provision in APO 2022-23. It has been agreed upon to complete the stipulated target of CA/PCA.
2. Smt. Jamuna Tudu, representative of tribal community discussed the need to address the problem of human-wildlife conflict in Chakulia. She suggested plantation of fruit bearing trees and other species in chakulia and Jamshedpur for wild life habitat improvement. The Committee was informed that the provision of plantation including fruit tree plantation have been made in the APO 2022-23
3. The Committee also discussed the proposals under Net Present Value (NPV) component for afforestation, wildlife habitat improvement, protection and improvement of forests through natural forest management, forest protection, and maintenance of permanent and Hi-Tech nurseries, infrastructure facilities for frontline staff etc. in details. As there is scheme from government for Gas chulha, hence to discourage fuel wood in chulha, it was decided to drop provision of unnat chulha from APO 2022-23 and include its budget in CAF Rule 5(3)(c) for Dragon torch.
4. Finance Secretary, Government of Jharkhand suggested to geo-tag all the water harvesting structures and to make polygons of those also. He also suggested to upload photographs of CAMPA works so that it is available in public Domain. He suggested to encourage bamboo plantation near water harvesting structure. It was informed that there is mandate to upload polygons of all works executed under CAMPA on e-green watch portal hosted by Government of India. So far 90 % of plantation sites and 87% of other than plantation work have been uploaded on e-green watch portal and Department is continuously working to upload polygons on e-green watch portal.
5. The Committee discussed launching of nursery portal which should include name, site/location/availability of type of plants with their numbers & price at which it is available. Provision shall be made for online purchase and may consider home delivery of the plants. It was informed that nursery portal is being designed & likely to be completed before next working season.
6. The Committee discussed on maintenance of forest roads, causeways and culverts. As causeways and culverts are the integral part of a forest road, the Committee decided to merge these under the head "Up gradation and maintenance of forest roads."
7. The Committee discussed at length on utility of solar lights and other items proposed under CAF Rule 5(3) c. It was decided to deduct the provision of ~~for~~ solar lights/ solar street light and these money to be included in purchase of dragon torches in desired numbers as man animal conflicts are increasing.

8. The Committee wanted to know the occupancy of previously constructed quarters. It was informed that previously made Forest guard quarters have been allotted to them and they are put to effective use.
9. The Committee was informed that apart from ongoing internal monitoring of CAMPA works, an independent third-party agency has also been engaged to evaluate the works undertaken from CAMPA funds. Monitoring work is in progress and is likely to be completed by March, 2022. Due to second wave of COVID 19, during April –May 2021, the progress was obstructed.
10. The Committee observed that adequate publicity measures and awareness generation programme may be undertaken in the year 2022-23 so that the general public and local communities become aware of the importance of forest, wildlife and biodiversity. It was informed that the provisions in this regard have been incorporated in the APO and very soon a booklet will be published on CAMPA works.

The Steering Committee approved the APO of 2022-23 of Jharkhand CAMPA for Rs. **79477.074 lakh** as follows.

2. List of members present is enclosed (**Annexure- I**).
3. The agenda items were taken up for discussion and following decisions were taken:-
  - A) **Agenda No. 1**: The proceedings of the meeting of the Steering Committee held on 03.06.2020 were confirmed.
  - B) **Agenda No. 2**: The Committee noted the provisions of Compensatory Afforestation Fund Act, 2016, Compensatory Afforestation Fund Rules, 2018, and guidelines issued by the Ministry of Environment, Forest & Climate Change, Govt. of India.

An approval of Rs. 381.06 crore for the Jharkhand CAMPA APO 2020-21 was granted by the State level Steering Committee in its meeting dated 03.06.2020. It was then sent to Govt. of India, CAMPA National Authority for its approval. The Executive Committee of CAMPA National Authority in its 7th meeting held on 30.06.2020 granted the approval of Rs. 376.56 crore for the CAMPA APO 2020-21.

The Committee discussed the progress against various schemes of APO 2020-21 as contained in the Annual Report of Jharkhand CAMPA for the year 2020-21 having summary of physical achievements, statement of Annual Account for the year and the Quarterly Progress Report ending March, 2021. The State Govt. had allotted a total budget of Rs. 251.79 crore for implementation of CAMPA APO activities against which an amount of Rs. 215.43 crore was utilized by the implementing units towards the activities under APO 2020-21. After discussion, the Annual Report 2020-21 was approved by the Committee.

**Agenda No. 3:** The CAMPA APO 2021-22 contains proposals with an outlay of Rs. 469.56 crore, as recommended by the Executive Committee of State CAMPA in its meeting held on 07.04.2021. The proposals placed before the Steering Committee in respect of APO 2021-22 were discussed in detail. The Govt. of India had directed that the activities to be included in the APO for 2021-22 should be taken up in accordance with the guidelines and provisions of CAF Rules. It was informed that the prescribed guidelines have been followed while preparing the said APO.

The Committee was informed about the progress of compensatory afforestation in the State. It was noted that for the year 2021-22, it has been proposed to carry out compensatory afforestation in a total area of 6,927.91 ha, which is the highest annual

target of compensatory afforestation so far. The Committee observed that the efforts must be made to clear backlog of compensatory afforestation in the next three years.

The Committee was informed that the proposals under Net Present Value (NPV) component relate to protection and improvement of forests through natural forest management, forest protection, silvicultural operations, soil and moisture conservation works, biodiversity conservation measures, and anti-depredation activities, etc. These are included in the proposals for wildlife habitat improvement, weed eradication, new grassland development etc.

The Committee observed that the activities under Catchment Area Treatment Plan and Integrated Wildlife Management Plan schemes should be taken up only after getting approvals from Competent Authorities. Further, particular emphasis should be given on schemes like silvicultural operations etc. which are important for the health of forests. A long-term holistic plan for such non site-specific activities should be prepared for better results.

The Committee also noted that the State Govt. has provided an initial budget provision of Rs. 219.25 crore for implementation of APO 2021-22. As against the proposed APO of Rs. 469.56 crore, implementation of various activities therefore, in the proposed APO will be initially limited to this amount after the final approval of National CAMPA, Govt. of India and the Finance Department would be requested for allotment of balance amount of funds.

After discussion, the Steering Committee approved the CAMPA APO 2021-22 of Rs. 469.56 crore as below:



With respect to the above subject, it is to state that by letter no 76 dated 07.02.2022 of this office, APO of Jharkhand for the year 2022-23 with the outlay of 794.77 crore after approval from State level Steering Committee under the Chairmanship of Chief Secretary of Government of Jharkhand.

By your letter no NA-15/27/2020-NA date 13.05.2022 an amount Rs. 371.95 crore have been approved and rest activities either have been deferred or not considered which are as follows-

Justification/details of these activities (deferred/not considered) are given below to consider these activities for approval-

**1. Integrated wildlife management plan (IWMP):**

It is site specific mandatory activity proposed under sec 6 (a) of CAF Act 2016.

Total forty IWMP with outlay of 89.6282 crore have been submitted in APO 2022-23. IWMP are prepared as per direction of GoI during diversion of forest land for non-forestry uses. These IWMP are prepared under the supervision of Principal chief conservator of Forests, Wildlife & Chief Wildlife Warden, Jharkhand of the state. By your sanction letter

no NA-15/27/2020-NA dt 13.05.2022, out of total outlay of these of 89.6 crore for 2022-23, only 45.00 crores have been approved.

List of the rest of the IWMP is attached with this letter as **Annexure-I**.

Kindly approve the rest 44.60 crore for IWMP so all the Integrated wildlife management plans are implemented.

## **2. Protection of Forests and Plantation Activities:**

This activity has been proposed under section 5(2)(d) of CAF Rule 2018 with outlay as 19.93445 crore.

The main components are Pillar and Activities for forest and wildlife protection.

The proposed Budget for pillar is 8.61 crore.

Only Rs. 5.00 (Five) crore have been approved by your letter no NA-15/27/2020-NA date. 13.05.2022 for demarcation & digitization of forest boundaries. It is requested to approve rest 3.61 crore for forest boundary pillars.

The proposed Budget for forest and wildlife protection activities is 11.32055 crore.

The abstract of components of forest protection and wildlife protection activities is as follows:

But budget in this activity has not been approved. It is requested to approve budget 11.32055 crore for forest and wildlife protection activities.

## **3. Wildlife Habitat Improvement and related activities**

It has been proposed under 5(2)(i) of CAF Rule 2018.

The State is endowed with rich flora and fauna. It has one National Park and 11 Wildlife Sanctuaries besides one Elephant Reserve and one Tiger Reserve (PTR). Under this component following initiatives are proposed to be taken for conservation of biodiversity. In addition, anti-depredation measures will be undertaken in all the Divisions of the State affected with elephants, and other wild animals etc.

Main interventions proposed are as follows:

- Wild life habitat improvement: It includes undertaking silvicultural operations to improve health of forests, weed eradication, grassland development, and soil & moisture conservation works etc.

It has been proposed to improve wildlife habitat of the state with total outlay of 76.36739 Crore But only 20.000 crore have approved. It is requested to approve rest 56.36739 crore. The detail activities in the rest 56.36739 crore are attached as **Annexure-III**.

**4. Advance work (1<sup>st</sup> year work) for Block plantation/Bamboo plantation on non-forest land falling in wildlife corridors**

The activity has been proposed under section 5 (2)(j) of CAF Rule 2018.

Block plantation and bamboo plantation will be done on non-forest land to enrich these areas which fall in wildlife corridor. It will reduce man-animal conflict and will improve Vegetation stretch for wildlife movement.

2300 ha have been proposed with total outlay of 15.65 crore.

But by your sanction order only Rs. ten crore have been approved. It is requested to approve rest of the 5.65 crore to carry out the complete target.

**5. Supply of forest produce saving devices: distribution of Solar Lamp**

It has been proposed under section 5(2) i of CAF Rule 2018 with the total outlay of 0.92 crore out 0.92 crore only 0.45 crore has been approved it is requested to requested to approve rest 0.47 crore so that requisite no of solar lamps be distributed among villagers. It saves forest produce.

**6. Maintenance of Nursery and improvement of infrastructure:**

The activity has been proposed under section 5(3) (a) of CAF Rule 2018.

Maintenance of 122.50 ha nursery with outlay of Rs. 16.32 crore has been proposed for 2022-23.

These are permanent nurseries established at different places to cater the additional need of plantation of indigenous and other species.

List of nurseries with details are attached as **Annexure-IV**.

Only Rs 8.00 (eight) crore have been sanctioned out of 16.32 crore. It is requested to approve rest amount 8.32 crore.

These permanent nurseries are very old. Hence strengthening and infrastructure development in these nurseries are required. Out of that, 36 nursery <sup>are</sup> ~~is~~ proposed for Infrastructure development in this APO. It has been proposed under section 5(3) (a) of CAF, Rules 2018.

The works done are site and requirement specific and include improvement of irrigation facility in nursery, improvement of fencing etc. Each nursery will be allotted maximum up to Rs. 7.50 lakh for such infrastructure development.

It is requested to approve 2.70 crore for infrastructure development in these established nurseries. Details of such nurseries are enclosed as **Annexure-V**.

## **7. Upgradation and maintenance of forest roads**

It has been proposed under section 5(3) (d) of CAF Rule 2018.

Total of 2863.177 km of forest roads have been proposed for maintenance. Maintenance with outlay of 12.026 crore. But only 05.00 crore have been approved. Maintenance of forest road is very essential to go inside the interior of forest for its protection and conservation. The forest of Jharkhand is very undulating and hilly. Hence maintenance of forest road is required after every raining season. The forest road is not black topped by this fund. These are murram forest road and require yearly/regular maintenance. Hence it is requested to approve rest 7.026 crore for maintenance of forest roads which also includes costs of construction of causeway and culvert in 15 divisions. The total cost included for construction of causeway and culvert is 4.8114 crore which is included in this rest amount of Rs. 7.0266 crore. The number of new causeway and culverts proposed to be constructed on these forest roads are 45 and 60 respectively. These are ~~requested~~ <sup>required</sup> to be constructed for smooth patrolling and connectivity of these forest roads. These will be constructed in inaccessible forest area to facilitate movement. It will help in protection of forest and wildlife. It will have direct impact on improvement in regeneration of forests.

Hence it is requested to approve the above activities for amount 7.0266 crore. (Rs. 2.2152 crore for maintenance of murram road and Rs. 4.8114 crore for construction of causeway and culvert.)

## **8. Awareness Generation, promoting voluntary activities/study tours on conservation methods and best practices (Publicity-cum-awareness programme)**

It has been proposed under 5(3)(j) of CAF Rule 2018 with outlay of 2 crore these will be used for awareness generates purpose among school/college/university students and others for conservator of the forests and wildlife.

All forest divisions would be involved in awareness generation programmes, especially school students of urban as well as rural areas, who would be given exposure to in-situ and ex-situ conservation areas. Publicity for carrying out compensatory afforestation and other activities under CAMPA and organizing programmes at State Hqrs. As well as in all the territorial Divisions are proposed to be undertaken. It is also proposed that around 200 schools consisting of around 5,000 children would participate in day-long visits to important wildlife. Forest and biodiversity areas and these students become aware of the importance of forest, wildlife and biodiversity and their importance in day-to-day life and for critical maintenance of life-line ecosystem services as well as combating desertification and mitigating/adapting for climate change. As in previous years, study tours would be organized for students & youth to important forest areas to make them aware about the activities carried out for conservation of forests and wildlife; Professional/Experts may also be engaged, if required, for this purpose.

Only one crore has been approved It is requested to approve rest Rs. one crore.


