

1. Part-I (a) Brief description of Forests and Forestry sector in West Bengal.


West Bengal (area 88,752 sq km) is the only Indian state to have a coastal line as well as the Himalayas and is situated between 21°20′N and 27°32′N latitude and 85°50′E and 89°52′E longitude. The state of West Bengal has a recorded forest area of 11,879 sq km. The forest areas are classified into three categories-(i) Reserved forest with an area of 7054 sq km. (ii) Protected forest with an area of 3772 sq km & (iii) Unclassed State Forest with an area of 1053 sq km. This constitutes 13.38% of the total geographical area of the state. The forest cover includes both notified forest area and afforestation created outside forest and it constitutes 21.35% of the geographical area of the state.

The State accounts for 2.69% of the country's geographical area and supports approximately 7.54% of the population. The population density of the State with 1029 persons per sq. km is one of the highest in the country. The demand of the huge population on the limited natural resources i.e. the land and forests exerts a tremendous negative impact on these resources.

Forest department of West Bengal thus pioneered on innovative strategies to conserve forest resources such as Public participatory-Joint Forest Management. Also Forest Department has been implementing various schemes to increase the forest and tree cover through promotion of Social Forestry, Farm Forestry, Agro Forestry, Community Forestry and Afforestation on wasteland, panchayat land that are outside the notified forest areas.

In this back ground Compensatory Afforestation done in substitution of diverted forest land holds its significance.

The Supreme Court in its order in T.N. Godavarman Thirumulpad vs Union of India and Others (Writ Petition (Civil) No. 202 of 1995), dated the 30th October 2002, observed that a Compensatory Afforestation Fund be created in which all the monies received from the user agencies towards compensatory afforestation, additional compensatory afforestation, penal compensatory afforestation, net present value of the diverted forest land or catchment area treatment plan shall be deposited. Accordingly The Compensatory Afforestation Fund Act, 2016 and Compensatory Afforestation Fund Rules, 2018 was formed. This Annual Plan of Operation is prepared as per form xii under rule 39 of Compensatory Afforestation Fund Rules, 2018.

Chief Secretary initiated the discussion and requested Additional Chief Secretary, Forest to brief the members about newly constituted West Bengal Compensatory Afforestation Fund Management and Planning Authority (WBCAMPA). Welcoming the members of the Steering Committee, Additional Chief Secretary, Forest Department gave the outline of the newly constituted West Bengal Compensatory Afforestation Fund Management and Planning Authority.

Shri Sandipan Mukherjee, Addl. Principal Chief Conservator of Forests & Nodal Officer, FCA, 1980 and CEO, WBCAMPA introduced the provisions of Compensatory Afforestation Fund Act, 2016, Compensatory Afforestation Fund Rules, 2018, Compensatory Afforestation Fund (Accounting Procedure) Rules, 2018. He also gave details of newly created CAMPA authority including its structure.

~

The CEO, CAMPA, presented the Annual Plan of Operation (APO) for the financial year 2019-20 to the tune of Rs.42.00 crore for discussion and approval.

The Chief Secretary, West Bengal and Chairman of the Steering Committee desired that in view of availability of sufficient fund the CAMPA authority should try to undertake more projects in 2019-20. The initial APO of Rs.42.00 crore was approved with a suggestion that CAMPA authority should undertake a fresh exercise and increase the APO to about Rs.70.00 crore.

It was decided that priority should be given to following items of work in APO:

- Action to be taken to ensure that the endangered local plant species and species of biodiversity values should be given priority in plantations done under CAMPA.
- As Joint Forest Management is an important tool for forest protection so alternate livelihood programmes for the JFM members like Apiary, Poultry, Sal leaf plate making, Mushroom cultivation are included in JFM component of APO.
- Self-help Groups (SHG) which are already working effectively in different projects of Forest Department may be strengthened further under CAMPA.
- Forest degradation for fuel wood needs to be controlled so component of promotion of LPG in villages, surrounding forest areas should be increased, by designing suitable subsidy scheme for forest villagers.
- In the hilly areas of the state under the component of Catchment Area Treatment / Soil Conservation works of vulnerable landslide zones should be given priority for conservation and stabilization of such areas.
- In view of flexibility in CAMPA, some innovative works for forest conservation, protection and improvement of livelihood of fringe population should be initiated.
- The annual target of works in WBCAMPA will increase in future, so capacity building of personnel and infrastructure development works of institution is to be taken up in WBCAMPA.

The meeting en did with vote of thanks to all present.
