CAMPA/C.R.05/374/2020-21 dated 1<sup>st</sup> December, 2020 have submitted details of deferred Soil Moisture Conservation works for seeking approval of the Executive Committee of the National Authority. State Authority has furnished components of works proposed with cost estimates and location details have been provided as Compartment No. only. Geo coordinates of proposed Soil Moisture Conservation works have been submitted vide letter number Desk-CAMPA/C.R. 05/2020-21/452 dated 07.01.2021 from State Authority.

3. The proposal of Maharashtra State Authority regarding deferred SMC works as recommended by the State Steering Committee of the tune of Rs 65.00 crores is placed for consideration of the Executive Committee of the National Authority.

#### Consideration of Deferred and Non-Permissible Activities: APO of Goa State Authority - Approval for Rs. 1.87 crore

The State Government of Goa vide letter No.6-804/Corres/Steer/2020-21/CAMPA-FD/Vol V/08 dated 11<sup>th</sup> April, 2020 furnished their APO to National Authority and considered it in the 5<sup>th</sup> meeting of Executive Committee of the National Authority held on 23.4.2020 and after their recommendation approval of Rs.11.73 crores was conveyed to the State Government for carrying out mandatory activities during current financial year 2020-21 vide NA's letter dated 14.5.2020

2. It is further mentioned that this proposal was again placed before the Executive Committee of the National Authority in its 5<sup>th</sup> meeting of EC on 24.4.2020 and approved under section 15 (1) (i) of the Compensatory Afforestation Fund (CAF) Act, 2016 for the remaining activities of the Annual Plan of Operation – Goa (2020-21) at a total cost of  $\gtrless$  20.96 crores (Rupees twenty cores and ninety six lakhs) out of proposed outlay of Rs.32.68 crores recommended by the State Steering Committee the current financial year from the "State Compensatory Afforestation Fund – Goa" created under Section 4 of CAF Act, 2016.

3. The Remaining activities of the APO were discussed in the 6<sup>th</sup> meeting of the Executive Committee of the National Authority held on 27.05.2020. The component wise approval accorded by the Executive Committee is as under

4. The Addl. Principal Chief Conservator of Forests, & CEO, Goa, vide letter No. For.6804/STER/COMM/CAMPA/FD/3026 dated 26.10.2020 requested for Sanction and Release of fund under CAMPA for APO 2020-21.

5. In this connection to above mentioned subject that vide above reference letter Rs. 2.32 Crore was kept on hold/ deferred in respect of APO for State CAMPA for the year 2020-21 "Construction of Nature Education Centre at Cotigao. Netravali Mollem and Madei WLS", Rs. 1.6 crores as proposed has been kept on hold/ deferred for adequate justification of activities.

6. It was proposed to set up Nature Education Centre at 4 wildlife sanctuaries in Goa. These wildlife sanctuaries were notified about more than 20 years ago but claims of villagers have not been settled as yet due to which villagers of these areas ate agitated and at loggerheads to Forest Department.

7. In this connection, the Goa Forest Department has proposed to setup nature education centre at these locations viz Cotigao WLS, Netravali WLS, Bhagwan Mahavir WLS, Mollem and Madei WLS. The Nature education centre will consists of wooden huts for accommodation besides small Nature Education Centre (NIC) trekking path etc. and about 50 local youths for each of these wildlife sanctuaries shall be trained as Nature guide for education and guiding the visitors during their visit to sanctuary.

8. As per the communication from Goa Forest Department setting up of nature education centre and creation of livelihood opportunities will catalyze society's role in conservation. Cost of each wooden hut is about Rs. 10 lakhs and it is proposed to establish 14 wooden huts at Cotigao (3), Netravali (4).Mollem (4) Bondla (3) Besides this, nature trails shall be created and about 200 local youths shall be trained as Nature Guide.

9. The Compensatory Afforestation Fund (CAF) Act,2016 for the Annual Plan of Operation for the year 2020-21 already approved **Rs.32.68** crores out of proposed outlay of **Rs.35.43 crore** recommended by the State Steering Committee for carrying out approved activities during the current financial year from the 'State Compensatory Afforestation Fund. In this connection **Rs.2.32 crore** have been deferred for want of adequate justification of activities (under Rule 5), As agreed, upon by CEO State Authority for reduction of **Rs.0.10 crore** for office equipment and **Rs.0.35 crores** on account.

11. The deferred items of the Annual Plan of Operation of Goa State Authority for 2020-21 is placed for consideration of the Executive committee of the National Authority.

### Consideration of Deferred and Non-Permissible Activities: APO of Andamans & Nicobar State Authority - Approval for Rs 8.10 lakh

Andaman & Nicobar State Authority vide their letters no. CAMPA/2/492 dated 9<sup>th</sup> January, 2020 and State CAMPA/2/627 dated 5<sup>th</sup> March, 2020 had submitted their Annual Plan of Operation for the year 2020-21 having a proposed outlay of Rs.4.37crores. The APO was approved in the 5<sup>th</sup> and 6<sup>th</sup> meeting of the Executive Committee of the National Authority held on 23<sup>rd</sup> April, 2020 and 27<sup>th</sup>&28<sup>th</sup> May, 2020 respectively for a total amount of Rs 2.13 crore. As procurement of camping equipment, motor-cycles, four wheelers, mini trucks, water tankers, dingy etc. are not permissible under Rule 5(2) of CAF Rules, 2018; and construction of toilets and change rooms are not permissible under Rule 5(3) of CAF Rules, 2018, these activities amounting to Rs 2.23 crore were not approved.

The Andaman and Nicobar Administration, vide their letter No. FCA/CAMPA/2/74 dated 26.06.2020 and PCCF/STATE CAMPA/9/253 dated 08.10.2020 has submitted the justification for above activities and stating that these activities form part of the permissible activities under Rule 5 of CAF Rules, 2018, they have sought their approval. The justifications are enclosed as Annexure "A" & "B" to the note.

The above items of the Annual Plan of Operation of Andamans & Nicobar State Authority for 2020-21 is placed for consideration of the Executive committee of the National Authority.

### Consideration of Deferred and Non-Permissible Activities: APO (2020-21) of Panjab State CAMPA

Two requests for reconsideration regarding approval of following deferred activities/activities not agreed to pertaining to APO (2020-21) of Panjab State CAMPA have been received vide letters no. State Authority/2020-21/SPL/120 dated 22.09.2020 and no. State Authority/2020-21/SPL/1834 dated 29.10.2020 respectively of Government of Punjab:

a. Construction of cattle pond (Bara) amounting to Rs 1.50 crore [Earlier proposed under per rule 5(2)(d), now under rule 5(2)(d)]

The above measure was included in the APO (2020-21) for tackling the damage of plantations from the serious problems of stray cattle. We may request the

State Government to submit a proposal for Cattle Proof Trenches(CPT)/ Cattle Proof Trenches(CPT), as per its applicability.

b. Revised proposal regarding Management of Zoological Parks, Mini Zoos, and Deer Parks at a cost of Rs 3.99 crore [Earlier it was Rs 6.53 crore]

The revised proposal includes funding on following grounds:

- i. Protection of the forests and wildlife area [Sub-rule 5(d)]
- ii. Forest fire prevention and control operations [Sub-rule 5(f)]
- iii. Soil and moisture conservation works in the wildlife areas [Sub-rule 5(g)]
- iv. Improvement of wildlife habitat as per approved wildlife management plan [Sub-rule 5(i)]
- v. Establishment, operation and maintenance of animal rescue centre and veterinary treatment facilities for wild animals [Sub-rule 5(k)]

2. It may also be noted that:

- a. The APO of the State Authority for Financial Year 2020-21 with a proposed outlay of Rs 187.82 crore was considered by the Executive Committee of the National Authority and the EC has approved it for a reduced financial outlay of Rs 177.85 crore.
- b. As per the progress report submitted by the State on 24.12.2020, the State Government had released Rs 45.09 crore only for the implementation of the above activities and the expenditure was Rs 46.79 crore.
- c. The physical and financial progress of the State is not visible on e-Greenwatch portal.
- d. FSI, Dehradun have found only 2283 polygons correct out of 4963 polygons checked till November 2020.

3. The above proposal of the Punjab State CAMPA is placed for the consideration of the Executive Committee of the National Authority.

### Consideration of Deferred and Non-Permissible Activities: APO (2020-21) of Telangana State Authority

Grounds for the consideration of following deferred items pertaining to APO (2020-21) of Telangana State Authority has been received vide letter no. 18595/CAMPA/2019 dated 20.11.2020 of PCCF (HoFF), Government of Telangana:

a. Protection of plantations and forests amounting to Rs 87.82 crore [Earlier proposed under per rule 5(2)(d), now under rule 5(2)(a)]

#### Agenda Notes for the 9th meeting of Executive Committee of National CAMPA

The activities include construction of high cost protection structure in forest blocks and urban forest blocks, namely See-through wall, Spill-over for See-through wall, Chain-link fencing, Spill over works for chain link, CRS Wall, 9" Compound wall, Spill-over for Compound wall. These were considered nonpermissible as these were high cost structure.

#### Grounds submitted:

- i. These are necessary for protection of lands from encroachers, to reduce the biotic interference from further degradation of forest, to improve natural regeneration and assisted natural regeneration.
- ii. These will help in meeting the national commitment for land degradation neutrality, increasing forest cover, improve biodiversity and increase carbon sequestration. Hence, it is now proposed under rule 5(2)(a)
- iii. Out of Rs 87.82 crore, Rs 63.9605 crore is meant for spill-over works related approved APO (2019-20) and only Rs 23.8595 crore is for fresh works. The grounded works are at different stages of completion.
- iv. Protection structures included in APO (2020-21) of Chhattisgarh and excavation of trench/other protective measures for protection of forests included in APO (2020-21) of Uttar Pradesh have been approved by the National Authority.
- b. Protection of of Medchal-Yadgarpally RF-I & II amounting to Rs 4.97 crore [a matter related to rule 5(2)(d) and proposed under per rule 6(b)(vi)].

The activity includes construction of high cost protection structure Chain-link fencing. Further, instead of proposing under rule 5(2)(d), it is proposed under per rule 6(b)(vi).

#### Grounds submitted:

- i. Same as mentioned in para a) above.
- Rule 6(a) (vi) permits the activities referred to in sub-rules (2) & (3) of Rule 5. Hence, construction of protection structures is a permissible activity under Rule 6(a)(vi).

#### c. Establishment of a CAMPA Monitoring Hall at a cost of Rs 3.00 crore [proposed under per rule 6(b)(d)]

#### Grounds submitted:

An amount of Rs.18.00 crore for establishment of CAMPA Capacity Building centre at Bhubaneswar was approved in APO (202-21) of Odisha under the same rule.

2. It may also be noted that:

- i. The APO of the State Authority for Financial Year 2020-21 with a proposed outlay of Rs 603.00 crore was considered by the Executive Committee of the National Authority and the EC has approved it for a financial outlay of Rs 483.78 crore.
- ii. **Telangana is not submitting any progress report**. As per the progress report submitted by the State on 30.09.2020, the State Government had released Rs 130.54 crore only for the implementation of the above activities and the expenditure was Rs 80.37 crore.
- iii. The physical and financial progress of the State is not visible on e-Greenwatch portal.
- iv. FSI, Dehradun have found only 1984 polygons correct out of 3962 polygons checked till November 2020.

3. The above proposal of the Telangana State CAMPA is placed for the consideration of the Executive Committee of the National Authority.

3. The observation with regard to details submitted by the State in respect of Deferred Items are as follows:

- a. They are division-wise with geo-coordinates.
- b. Unit cost is shown, but the basis of cost estimation or breakup is not furnished. At many places LS amount is mentioned. Unit cost of same work varies from division to division. For instance, it appears that "forest fire and control operation" includes wages of fires watchers, purchase of diesel for department vehicle for patrolling and fire protection, purchase of boots, caps, jerkins, bags, water bottles, shoes and masks, providing of food/ration, purchase of firefighting equipment etc., but sub-activity wise standard cost estimation has not been furnished anywhere.
- c. They are not systematic and activity-wise. Hence, it is impossible to arrive at activity-wise total.
- d. They even include activities not in the list of deferred activities, namely advance works (including raising of nursery), raising of seedlings, maintenance of CA plantations, maintenance of fire lines, watch towers, check posts, timber depots, survey and demarcation of forest boundaries, publicity and awareness for forestry and allied activities, boards and hoardings, signages, supply of solar street lights, supply of wood/energy –saving devices etc.
- e. General term as per sub-rules have been mentioned like "construction, upgradation & maintenance of inspection paths, forest road, fire lines, watch towers, check posts, timber depots", "forest fire and control operation", "construction of residential buildings for staff" etc. and it is very difficult to make out the individual activity.
- f. At most places, distinction between 80% and 20% activities (NPV) is not possible and wherever distinction has been made, activities related to modern nurseries, quality planting material, inspection path, forest roads, fire lines, watch towers etc. and construction of residential and official have been proposed under 80% NPV.
- g. Funding in respect of purchase of diesel for department vehicle for patrolling and fire protection, purchase of boots, caps, jerkins, bags, water bottles, shoes and masks, providing of food/ration, chain-link mesh for sandal plantation, protection of plantations and forests through compound wall, construction of ACF Office building and maintenance of Kalkere Research Station, the last at the cost of Rs 1.5 lakh and similar activities, which are not permissible, may be done through regular State Budget.
- h. The details with regard to the Research Activities could not be traced.
- i. Implementation schedule for activities like anti-poaching camps is proposed for the duration from April, 2000 to September 2000, which is already over.
- j. Maintenance of Vth to IX-year-old plantation and planting on CPT as spill-over work is not included in the list and may not be possible now.

- k. Pending payment of Rs 95.24 lakh has been included by Yellapur division without any description. It is not clear, if it is a part of the deferred activities.

The CEO, Uttar Pradesh State Authority vide letter no. 773/2-37-2 dated 24.12.2020 has submitted a fresh proposal for undertaking advance soil work in 9787.45 Ha at a cost of Rs 37.95 crore during current financial year from the NPV fund. It has been informed that during in the 4 th meeting of the Executive Committee of the State Authority held on 21.12.2020 a saving of Rs. 37.95 crore was anticipated on account of various reasons (i.e. reduced physical targets related to CA plantation, non-permission of purchase of vehicles, non-payment of salary and wages due to non-creation of new posts). This is based on the fact that the budget provision for CAMPA works is for Rs 275.19 crore. Hence, the Executive Committee formulated a plan for taking up advance soil work for plantation during 2021. This plan consists of division-wise physical and financial target for proposed activities. In addition, the EC also decided to inform the National Authority in this regard. In the light of the above decision, the CEO, State Authority has submitted the location wise (geo-coordinates) physical and financial targets of the proposed advance soil works. The State has also furnished the following comparative statement, after approval of the activities:

### Proposal of Jammu & Kashmir CAMPA: Approval regarding clearing claims of liabilities in respect of APO for 2019-20 amounting to Rs 7.681 crore.

The Jammu & Kashmir CAMPA vide letter No. PCCF/CAMPA/1109/3124-25 dated 23.10.2020 have sought approval of the National Authority with regard to clearing claims of liabilities amounting to ₹7.681 crore of implementing agencies related to APO (2019-20) from the approved outlay of APO for 2020-21, on account of some incomplete works/procurements or non-payments related to completed works/procurements by 31.03.2020 as COVID-19 pandemic enforced sudden lockdown from the third week of March 2020. It has been informed that the works were included in the APO of J&K CAMPA for 2019-20 approved by the Steering Committee of Jammu & Kashmir CAMPA in its meeting held on 14.01.2019 and 08.06.2020 for a total amount of ₹126.745 crore. However, the above liabilities could not be included in the APO for 2020-21, which was prepared much earlier, in Dec 2019.

2. It has been informed that a committee constituted as per decision of the Executive Committee of the State CAMPA in its meeting held on 09.06.2020 has ascertained the claims of liabilities from the implementation agencies after scrutiny of records of which  $\gtrless0.693$  crore is under CA,  $\gtrless0.0015$  crore is under additional CA

(Roadside plantation) and ₹7.6102 crore is under NPV (including under Protected Areas). The unspent balance available with J&K CAMPA, as on 31 March 2020, has also been transferred to the State Fund under public account on J&K Govt. Hence, the only recourse left is to seek the approval of the National Authority.

3. The above proposal has been examined and following additional information has been sought from the State CAMPA vide our letter dated 23.12.2020.

- 3. Technical features of the scheme are:

4. PARIVESH was launched by Hon. PM in August, 2018. On the basis of the initial financial proposal submitted by the NICSI in December, 2018 for deploying manpower regarding the implementation, maintenance and up-gradation of PARIVESH for the period 01.01.2019 to 31.12.2019, Rs.1,39,22,348/- was released to NICSI by the Ad-hoc CAMPA vide their sanction No 13-35/2016-CAMPA dated 09.01.2019. Thereafter, on the request of the NICSI received through the Forest Conservation Division, the duration of the existing project was extended up to 31<sup>st</sup> December, 2020. For this purpose, the NICSI was allowed to utilize an unspent balance of Rs. 68,33,522/- available with them besides the release of Rs. 72,98,568/- on 24/09/2020 by the National Authority after the concurrence of IFD and approval of HMEF&CC. It has been informed that as on 07-12-2020, an unspent amount of Rs. 14,72,997/- was available with NICSI.

A new financial proposal for Rs 2,31,96,128/- for deployment of manpower during 01.01.2021 to 31.12.2021 in this regard has been received from NICSI for seeking grant from the National Authority under section 5 (b) (iii) of the CAF Act,2016 with the recommendation of the Forest Conservation as per following break-up:

### Study on Impact of Sal Seed Collection on its Regeneration and its Market Dynamics" prepared by ICFRE and submitted by CS Division

A collaborative project proposal regarding "Study on Impact of Sal Seed Collection on its Regeneration and its Market Dynamics" at a total estimated cost of **Rs. 90.04 lakh** (Rs. Ninety lakh four thousand only) has been received from the ICFRE, Dehradun through the CS Division, MoEF&CC for seeking grant from the National Authority under section 5(b)(iii) of the CAF Act, 2016. The study is planned to be carried out in the states of Madhya Pradesh, Chhattisgarh, Jharkhand, West Bengal, Uttar Pradesh and Uttarakhand. TFRI, Jabalpur Jabalpur, FRI, Dehradun and Institute of Forest Productivity (IFP), Ranchi are the collaborators in this. The objectives of the scheme are:

- i. To identify promising areas of Sal seed collection and its trading.
- ii. To assess Sal seed regeneration pattern.
- iii. To study market dynamics of Sal seed and its products.

3. The ICFRE was requested by the CS Division, MoEF&CC to commission a detailed study on impact of Sal Seeds collection by tribal cooperatives/forest dwellers on Sal regeneration and impact on the life cycle of various stages due to seed collection in reference to a series of requests of Shri Vijay Baghel, Hon'ble M.P. to HMEFCC regarding the inclusion of Sal seeds under the Normally Traded as Commodities (NTACs).

4. Sal seeds have a diverse commercial application in products such as oils, soaps and cocoa butter equivalent in chocolate manufacturing purposes and is also a good source of 'aromatic gum' which is also known to have medicinal properties. Nearly 30 million forest dwellers, mostly tribal people, depend on the seeds, leaves and resins from Sal trees for their livelihood and earn nearly Rs.7-12,000 during a season by selling the collections to nearby local haats. They also benefit from mechanism for marketing of Minor Forest Produce (MFP) through Minimum Support Price and Development of Value Chain for MFP.

5. The action plan of the project will involve survey, collection of data, finalization of study sites and collection of baseline data on Sal seed, including collection during seeding period, to assess Sal seed regeneration pattern, survey and collection of data from the village level market (haat) in selected study sites, interview with the traders dealing in Sal seeds and its products, both at regional and national level, assessment of trading pattern of Sal seed and its product and culmination of the study with publication of reports supporting papers and pamphlets. The project is planned to be submitted in **2 years**.

6. The project outcomes are proposed to be helpful in understanding the status of Sal seed collection and its trading at regional and national level, developing database on Sal seed regeneration and its establishment in the selected zones of India, suggesting appropriate time of Sal seed collection for its sustainability and finally helpful in comprehending the market dynamics of Sal seed and its product value.

7. Monitoring the progress and implementation of the scheme will be the responsibility of the NAEB.

8. As per section 15(1)(ii) of the CAF Act,2016 the Executive Committee of the National Authority is to formulate the proposals for schemes specified in section 5 (b) (iii) of the CAF Act,2016. Hence, the proposal is placed for consideration of the Executive Committee of the National Authority.

A Pilot Project regarding Transitioning from Shifting Cultivation to Settled Land Use in the State of Nagaland A Pilot Project regarding Transitioning from Shifting Cultivation to Settled Land Use in the State of Nagaland at a total estimated cost of Rs. 40.01 crore (Rs. Forty crore one lakh only) has been received from the State Forest Department, Govt. of Nagaland through the NAEB, MoEF&CC for seeking grant from the National Authority under section 5(b)(iii) of the CAF Act, 2016. This will be implemented in one pilot village in each district of the State of Nagaland (total 12 villages) during a period of five years.

2. The main objective of the project is to convert jhum areas into areas that will be conducive to settled land use and will address the environmental, livelihood and economic issues through the following interventions:

- a. Construction of stone pitched earthen bunds in contour at suitable intervals in slopes in the first year and conversion of the bunds into strip terraces with construction of ridges and step like structures across land slope in the second and third year with the aim to reduce soil erosion and increased water availability for settled land use like agriculture and other economic enterprises.
- b. Treatment of vulnerable areas through vegetative and mechanical control measures such as trenching (T), earthen/stone bunding (B), biomechanical barrier (BB: stone/earthen bund/log-bunding or trench with grass/cuttings planting), gully plugging (GP) with vegetative and mechanical measures etc.
- c. Installation of micro power generating units such as Hydrogers and Biomass gasifiers for clusters of farmers for providing an assured power source for enabling enterprises to be established in the project villages.
- d. Adoption of economic crops (such as any endemic medicinal & aromatic plant or Non Timber Forest Produce species) for livelihood security with viable marketing potential during the transition period.
- e. Establishment of Common Processing Infrastructure for value addition of the crops raised under the above component and marketing of the products.
- f. Assistance in entrepreneurship development with an emphasis on building business and marketing skills through training on skills and market information.
- g. Creation of woodlots by growing bamboo and fast growing tree species for enhancing rural livelihood and for providing a source for green energy. This will also contribute to achieve the country's Nationally Determined Contribution (NDC) target of creating additional carbon sink.
- h. Skill Development & Capacity Building of members of FDAs, JFMCs/ FDCs for the furtherance of the objectives of the scheme.
- i. Institutional Strengthening to plan, implement, monitor and report in the project villages and also to support extension and strengthening of infrastructure at various levels.

5. As per section 15(1) (vii) of the Act, one of the powers and functions of the Executive Committee of the National Authority is to execute other day-to -day work in

# Fixing applicable rate of interest for the State Compensatory Afforestation Fund (State Fund) for the year 2019-20 and 2020-21

The Ministry of Finance vide OM No. 1(9)-B(AC)/2017 dated 24.11. 2020 have fixed the applicable rate of interest on the National Fund at 3.4% per annum for the year 2020-21. As regards the request of this Ministry to fix the interest rate of the State Fund, they have asked this Ministry to notify the same for the State Fund based on the rate of interest applicable for the National Fund.

2. The above communication is important as the Ministry of Finance in earlier communications while prescribing the applicable rate of interest on the National Fund at 6% per annum and 5.5% per annum for the year 2018-19 and 2019-20 respectively, had fixed the rate of interest on the State Fund for 2018-19 only and asked this Ministry to amend Section 4 (6) of CAF Act, 2016 in order to provide that each State Government would prescribe the annual rate of interest on the balances available under respective State Fund from 2019-20.

3. As per the provision contained in Sections 3(6), 3(7), 4(5) and 4(6) of the CAF Act, 2016 the National Fund and the State Fund are non-lapsable interest bearing fund under public account and get interest as per the rate declared by the Central Government on year to year basis.

4. In view of above, it is proposed to fix applicable rate of interest for the State Compensatory Afforestation Fund (State Fund) for the year 2019-20 and 2020-21 at 5.5% and 3.4% respectively.

5. The proposal was referred to the IFD, MoEF&CC. They have advised to take a decision, as appropriate, keeping in view the Department of Economic Affairs' OM No. 1(9)-B(AC)/2017 dated 24.11.2020. Further, since this is a policy matter involving State Government also, the decision so taken may be placed before the Executive Committee and Governing Body of NA, for their approval.

6. The proposal is placed for consideration of the Executive Committee of the National Authority before seeking kind approval of the HMEF&CC.

#### Preparation of Detailed Project Reports (DPRs) for Rejuvenation of Damodar and Subarnarekha Rivers through Forestry Interventions.

A project proposal regarding "Preparation of Detailed Project Reports (DPRs) for Rejuvenation of Damodar and Subarnarekha Rivers through Forestry Interventions" at a total cost of Ra 1.17 crore (Rs one crore seventeen lakh only) has been received from the ICFRE, Dehradun through the NAEB, MoEF&CC for seeking grant from the National Authority under section 5(b)(iii) of the CAF Act, 2016. A brief on the two proposals is as under:

#### Damodar River

Damodar, a rain-fed river originates near Khamarpat hill on Chhota Nagpur plateau near Chandwa of Palamau district of Jharkhand. Damodar basin is regarded as the storehouse of Indian coal. It is a highly industrialized zone, having a large number of coal mines and coal-based industrial establishments, thermal power stations, coal washeries, such as steel plants, metal smelting plants, metal alloy, steel re-rolling mills, chemical plants, cement mills, beehive cock oven plants, refractories, mica and glass industries, as well as lime and brick kilns. Thus, there is an urgent need to address these issues, and come up with an integrated approach to meet decreasing E-Flow of river Damodar in order to sustain the river biodiversity.

#### Subarnarekha River

Subarnarekha also a rain-fed river, originates from the state of Jharkhand and flows across West Bengal and Odisha. The river in Jharkhand passes through one of the richest mineral beds in the world. Considering the great reserves of minerals and other natural resources in the river basin and its significance in the eastern part, a welldefined rejuvenation plan for the Subarnarekha river system needs to be formulated, addressing the various issues including flood, pollution, river eco-system, ecological development and natural resource management while providing socio-economic support to rural living in the vicinity of the river.

2. **OBJECTIVE:** The broad objective the preparation of the DPR is to rejuvenate major river systems of the country through forestry interventions. Specific objectives of the study are to:

- Review and assess the existing situation of river basin, past river management & implications and lessons learned
- Identify and involve stakeholders and build consensus for design and development of strategies and approaches

- Assess the conditions of riparian forests and potential of biological filters
- Examine the possibility of allied and other income generation activities
- Assess the potential of cultivation of medicinal plants and restoration of conservation areas and identify appropriate species and suitable sites
- Identify and develop a strategy for future research and monitoring, and
- Formulate strategies, develop approaches, and plan activities for project implementation.

3. **APPROACH:** Logical Framework Approach will be followed for preparation of the Detailed Project Reports of Damodar and Subarnarekha river systems.

4. **METHODOLOGY:** A multi-criteria (MCA) analysis approach will be followed to identify the treatment priority area. Major areas of concentration will be on River-scape analysis; Collection and Preparation of Spatial and Attribute Data; Rejuvenation Models for the Identified Priority Areas; and Sensitization and Capacity Building.

5. **PROJECT DURATION:** 18 months from the receipt of 1<sup>st</sup> instalment of funds after award of the study.

#### 6. ESTIMATED COST: Total Rs. 117.46 lakhs

- Damodar River -Rs. 60.77 lakhs
- Subarnarekha River- Rs.56.69 lakhs
