The State was advised to fund the above activities from other sources and not from CAMPA. 6 Agenda Item No. 9: Consideration of Action taken report will be informed in Deferred and Non-Permissible Activities: the next meeting of APO (2020-21) of Telangana State CAMPA Executive the **Decision:** The EC did not agree to the Committee. proposal of the PCCF (HoFF), Government of Telangana received vide her letter 18595/CAMPA/2019 dated 20.11.2020 regarding construction of high cost protection structures in forest blocks and urban forest blocks at a cost of Rs 87.82 crore and at Medchal-Yadgarpally RF-I & II at a cost of Rs 4.97 crore. The PCCF (HoFF) justified the proposed structures, especially in urban forest blocks, which are vulnerable encroachments due to high cost of land. She

informed that it is not possible to cover these areas under Nagar Van Scheme. The EC noted that this may be a common problem in many States/UTs and felt the need to formulate a new scheme for the protection of such forest land from the National Fund. The State was advised to re-submit the proposal thereafter to the National Authority for consideration. Establishment of a CAMPA Monitoring Hall at a cost of Rs 3.00 crore was also deferred. The State was advised to fund it from other sources and not from CAMPA. 7 Agenda Item No. 10: Consideration of Action taken report Deferred and Non-Permissible Activities: will be informed in APO (2020-21) of Karnataka State CAMPA the next meeting of **Decision:** The EC considered the proposal of Executive the the State CAMPA submitted vide their letter Committee. APCCF/(CAMPA)/BUD/CR-41/2020-21 dated the 17th October 2020 regarding deferred activities amounting to Rs 43.69 crore and activities not agreed to amounting to Rs 51.80 crore pertaining to APO (2020-21) of Karnataka State CAMPA. Issues related to deferred activities were discussed and the EC noted that all the submitted activities have been clubbed and advised the state to submit the activities item-wise. The EC will consider for approval when the revised proposal is submitted as per the 80:20 principle explained in the opening para of the minutes. Activities not agreed to amounting to Rs 51.80 crore were not considered. The State would submit the recast APO to the National Authority for

approval.

Agenda No. 12: Approval regarding clearing claims of liabilities amounting to Rs 7.681 crore: APO (2019-20) of Jammu & Kashmir State CAMPA.

**Decision:** The EC considered the proposal submitted by the State CAMPA vide their letter no. PCCF/CAMPA/1109/3124-25 dated 23.10.2020 and advised the CEO, State CAMPA to include the proposal either in a Supplementary APO (2020-21) or in the fresh APO (2021-22).

Action taken report will be informed in the next meeting of the Executive Committee.

Agenda Item No: 13 : Additional/ Supplementary APO (2020-21): Uttarakhand State CAMPA

**Decision**: The Uttarakhand CAMPA vide their 663/GoI/2020-21 letter no. 19.10.2020 submitted a Supplementary APO (2020-21) for a total financial outlay of Rs 262.49 crore. The APO was approved by the State Steering Committee in its meeting held on 12.10.2020. The above is in addition to already approved APO (2020-2021) for Rs 255.09 crore. Against this, the State has released fund amounting to Rs 185.86 crore and the total cumulative expenditure was Rs 110.66 crore (43%) as per the latest progress report. Against a total proposed plantation of 6141.47 Ha, the achievement is 5161.64 Ha (84%). The State CAMPA informed that they have an unspent balance of around Rs 80.00 crore, which is sufficient for implementation of previously approved APO (2020-21) and the balance activities of 2019-20. The above act of the State CAMPA is contrary to the directions issued to the State Government vide Ministry's letter no. NA-15/1/2020-NA dated 15.07.2020. The State CAMPA will receive remaining amount under Supplementary Budget for 2020-21 based on the approval of the National Authority. With the above proposal, the total size of the APO (2020-21) will become Rs 487.58 crore. The EC noted that the focus of the

Supplementary APO for 2020-21 is on soil & moisture conservation and protection of

forest and wildlife and only Rs 18.34 crore has been kept for afforestation activities. The EC also noted that in respect of many proposed activities (e.g. Assisted Natural Regeneration, Artificial regeneration, Management of Biological Diversity &Biological Resources, Protection of Bugyals etc.), just a lump-sum amount has been mentioned and wherever unit furnished, the basis of cost estimation has specified. Activities not been proposed regarding Corbett are required to be referred to National Tiger Conservation Authority for their opinion/comments. Activities Establishment of Eco Clubs in 2000 schools and Establishment of Eco Clubs/Nature Parks may not be permissible under CAF, Rules. In addition, the APO should comply with the 80:20 conditions explained in the opening para of the minutes. The EC advised the CEO, State CAMPA to resubmit the revised APO as discussed.

Agenda Item No: 14 : Additional APO (2020-21): Chhattisgarh State CAMPA

**Decision:** The Chhattisgarh CAMPA has submitted an Additional APO (2020-21) for a total financial outlay of 416.28 crore after the approval of the State Steering Committee. The above is in addition to already approved APO (2020-2021) for Rs 963.24 crore. Against this, the State has released fund amounting to Rs 441.39 crore, which is also the total cumulative expenditure (45%). The State CAMPA has achieved the total proposed plantation target of 6103.98 Ha. With the above proposal, the total size of the APO (2020-21) will become Rs 1379.52 crore.

The EC noted that the focus of the Additional APO for 2020-21 is on soil & moisture conservation (Rs 290 crore), high cost protection structures (Rs 26.84 crore), IT/Office Automation (Rs 5.00 crore) and only Rs 3.38 crore has been kept for afforestation

activities. The EC also noted that the proposal for wetland conservation will require opinion/comments of Wetland Division of the Ministry. Viewing limited time period available in financial year 2020-21, the EC observed that the remaining activities of the approved APO (2020-21) may first completed. At the same time 'in principle' approval was accorded to the State Authority to take up afforestation activities subject to condition that they will submit a revised proposal complying with the 80:20 conditions explained in the opening para of the minutes.

### Agenda Item No. 15: Proposal for "Maintenance, Enhancement and Upgradation of Forest Clearance Module of PARIVESH".

**Decision:** The EC considered the proposal submitted by the FC Division regarding sourcing of manpower support through NICSI at a cost of Rs 2,31,96,128/- for the period 01.01.2021 to 31.12.2021 for funding from the National Authority. This is an ongoing proposal, which includes provision for additional deployment of 12 project support staff (9 at newly created IROs and 3 at ROHO in the Ministry). The EC advised Division/NICSI to henceforth submit the proposal financial year wise. The EC also desired that a suitable officer of NICSI should remain present in the future EC meetings, whenever their matter is discussed. The EC recommended for funding the proposal from the National Authority for the period 01.01.2021 to 31.03.2021 at a cost of Rs 57,99,032/-minus the unspent balance available with NICSI as on 31.12.2020. It addition, it advised FC/NICSI to submit the proposal for 2021-22 by the end of this month.

Finance, Deptt. of Expenditure OM No. 1(9)-

B(AC)/2017 dated 24.11.2020 requesting MoEF&CC to notify the applicable interest rate for State Compensatory Afforestation Fund based on the rate of interest applicable for the National Compensatory Afforestation Fund. In an earlier communication, while fixing the annual rate of interest for the year 2018-19 for the National Fund as well as the respective State Funds, the Department of Expenditure suggested an amendment in CAF Act in order to provide that each State Government would prescribe the annual rate of interest on the balances available under respective State. Hence, seeking legal opinion on this issue was also discussed. Finally, the EC recommended the proposal to fix the proposed applicable rate of interest for the State Fund for the year 2019-20 and 2020-21 at 5.5% and 3.4% respectively, which are the applicable rates of interest for the National Compensatory Afforestation Fund for the approval of HMEFCC.

Agenda Item No. 20: Preparation of Detailed Project Reports (DPRs) for Rejuvenation of Damodar and Subarnarekha Rivers through Forestry Interventions.

**Decision:** The EC considered the proposal of ICFRE at a total cost of Rs 1.17 crore and 18 months' duration for funding from the National Authority. The project was examined by NAEB. The EC recommended it for the approval of the Governing Body of the National Authority. Monitoring the progress and implementation of the project will be the responsibility of NAEB.

Agenda Item No. 21: Satellite Survey of Encroachment position of Rejected claims as per Order of Hon'ble Supreme Court in Writ Petitions (civil) No(s) 109/2008 Wildlife First & Others Vs Ministry of Forest and Environment & others.

**Decision:** The EC considered the proposal of FSI at a total cost of Rs 48.00 crore and covering six years' duration for funding from the National Authority. This was discussed at

Monitoring the progress and implementation of the project will be the responsibility of FP Division.

Agenda Item No. 22: No cost extension of Scheme "Execution of Readiness Activities for Implementation of REDD+ in India" submitted by ICFRE

**Decision:** The scheme was approved in the first meeting of the Governing Body of the National Authority for the duration of 09 months with the budget of Rs. 120.04 lakh. First installment of Rs. 72 Lakh was also released. However, due to COVID-19, the implementation of the programme got delayed and the ICFRE has sought a 'no cost extension' of the scheme till 31.12.2021, which has been recommended by the RT Division. The EC considered the proposal and agreed to it.

Agenda Item No. 23: No cost extension of Scheme "National Program for Conservation and Development of Forest Genetic Resources (FGRs): Pilot Project on Creation of Centre of Excellence on Forest Genetic Resources"

**Decision:** The ongoing scheme approved by the National CAMPA Advisory Council (NCAC) with a total financial outlay of Rs. 8.61 crores for a period of 5 years (2016 to 2020-2021) was approved in the first meeting of the Governing Body of the National Authority. Till date, a sum of Rs. 7.74 crore has been released (Rs. 6.646 crore by Ad-hoc CAMPA + 1.095 crore by National Authority). The balance amount of Rs. 86.35 lakh is yet to be released. Due to COVID-19, the implementation of the programme got

delayed and the ICFRE has sought a 'no cost extension' of the scheme till 31.03.2022. The EC considered the proposal and agreed to it.

Agenda Item No. 24 : Monitoring the

progress of implementation of CAMPA activities through E-Greenwatch Portal **Decision:** The EC noted that the quantity and quality of the polygons of CAMPA activities uploaded on e-Greenwatch portal by States are not satisfactory. The EC felt a need of further capacity building of the State officers on how to use e-Greenwatch. DG. FSI informed that a training programme for the officers of States will be started from 15.01.2021. On the basis of the feedback received from the States, the EC advised DG, FSI to take prompt action in removing the glitches of the technical portal, establishment of FSI Desk in all States, establishment of a Help Desk in NIC, Bhopal, hand-holding of the States and shifting from google-based imagery to more precise NRSEbased imagery. The EC also emphasised the need to sufficiently increase the storage space of the portal for smooth uploading of timeseries photographs of all plantations and inspection reports. DGF&SS requested DG, FSI to develop standard protocols in respect of loading of the photographs and inspection notes. He also informed that a complete rehaul of the PARIVESH portal is underway where all clearances will be merged into one. Further, an organic link between PARIVESH and e-Greenwatch will be established soon and thereafter the KML files uploaded on PARIVESH will not be required to uploaded again on e-Greenwatch.

### **Agenda Item No.3**

### Revised Supplementary APO (2020-21): Uttarakhand State CAMPA

The Uttarakhand CAMPA vide their letter no. 876/GoI/2020-21 dated 29.01.2021 have submitted a revised Supplementary APO (2020-21) for a total financial outlay of Rs 26249.07 lakh. The State CAMPA vide their letter no. 663/GoI/2020-21 dated 19.10.2020 had submitted a Supplementary APO,

which was discussed in the 9<sup>th</sup> meeting of the Executive Committee of the National Authority at Agenda Item No. 13. Excerpts of the minutes of the meeting are as under:

"The above is in addition to already approved APO (2020-2021) for Rs 225.09 crore. Against this, the State has released fund amounting to Rs 185.86 crore and the total cumulative expenditure was Rs 110.66 crore (43%) as per the latest progress report. Against a total proposed plantation of 6141.47 Ha, the achievement is 5161.64 Ha (84%). The State CAMPA informed that they have an unspent balance of around Rs 80.00 crore, which is sufficient for implementation of previously approved APO (2020-21) and the balance activities of 2019-20. The above act of the State CAMPA is contrary to the directions issued to the State Government vide Ministry's letter no. NA-**15/1/2020-NA dated 15.07.2020.** The State CAMPA will receive the remaining amount under Supplementary Budget for 2020-21 based on the approval of the National Authority. With the above proposal, the total size of the APO (2020-21) will become Rs 487.58 crore. The focus of the Supplementary APO for 2020-21 is on soil & moisture conservation and protection of forest and wildlife. The EC noted, however, that in respect of many proposed activities (e.g. Assisted Natural Regeneration, Artificial regeneration, Management of Biological Diversity & Biological Resources, Protection of Bugyals etc.), just a lump-sum amount has been mentioned and wherever unit cost is furnished, the basis of cost estimation has not been specified. The work of forest protection and SMC needs to directly relate to the regeneration of forests with quantifiable monitoring parameters. Activities proposed regarding Corbett are required to be referred to National Tiger Conservation Authority for their opinion/comments. Activities like the Establishment of Eco Clubs in 2000 schools and the Establishment of Eco Clubs/Nature Parks may not be permissible under CAF, Rules. In addition, the APO should comply with the 80:20 conditions explained in the opening para of the minutes. The EC advised the CEO, State CAMPA to resubmit the revised Supplementary APO 2020-21 as discussed at the earliest so that the same could be considered in the next EC meeting being scheduled shortly."

The observations regarding the revised Supplementary APO (2020-21) are as follows:

- a) No explanation has been furnished with reference to directions given by the Ministry in respect of utilization of unspent balance.
- b) It remains essentially the same, except some surface-level changes. Activity-wise remarks are given in the following table.
- c) No quantifiable monitoring parameters have been furnished.
- d) With regard to activities proposed regarding Corbett, the State CAMPA has submitted letter F.No. 15-30(15)/2015-NTCA dated 27.12.2017 and 13.02.2019 that may not be relevant in the present context.

e) Majority of the activities proposed are spilling over to the next FY 2021-22. Thus, it is an APO more for FY 2021-22 than the current year. Such activities are required to be excluded from the APO.

### Agenda Item No.5: Revised APO (2020-21) of State CAMPA, Arunachal Pradesh

The State CAMPA, Arunachal Pradesh through their e-mail dated 26.01.2021 have submitted a revised APO (2020-21) for a total financial outlay of Rs 214.905 crore. The State CAMPA vide their letter no. FOR/03/CAMPA/2020/1577 dated 28.09.2020 had submitted an APO, which was discussed in the 9<sup>th</sup> meeting of the Executive Committee of the National Authority at Agenda Item No. 4. Excerpts of the minutes of the meeting are as under:

"The Arunachal Pradesh State CAMPA vide their letter no. FOR/03/CAMPA/2020/1577 dated 28.09.2020 submitted a consolidated APO for 2019-20 & 2020-21. The APO was approved by the State Steering Committee in its meeting held on 12.08.2020 for a total outlay of Rs. 316.74 crores. Deficiencies observed in the APO were communicated to the State CAMPA. It was inter alia intimated that separate APOs for year 2019-20 and 2020-21 were required to be submitted timely and APO for 2019-20 would be considered tor ex-post-facto approval for permissible activities already undertaken on actual basis as per guidelines issued by the Ministry and activities not initiated during 2019-20 would not be considered. In reply, the State CAMPA have informed that no works have been taken up either against the APO for 2019-20 or 2020-21 as they have not been approved and requested for their approval. In such a scenario, there is no justification for approving APO for 2019-20, as all works need to be included in APO of 2020-21. The APO for 2020-21 was placed before the EC for consideration. The EC noted that the APO consisted of a number of non-permissible activities. The EC also noted that activities, namely site preparation, nursery raising etc. could still be undertaken during January to March 2021. In addition, the APO should comply with the 80:20 conditions explained in the opening para of the minutes. Chairman directed that officers of National Authority help CEO State Authority so that the APO could be recast quickly and the matter may be placed before the next EC. PCCF (HoFF) will also arrange a compliance report regarding depositing unspent balance in the State Compensatory Afforestation Fund (State Fund) as per D.O. No. 9//2020-NA dated 22.12.2020 of HMEFCC."

The observations regarding the revised APO (2020-21) are as follows:

- (a) The compliance report regarding depositing unspent balance in the State Fund as per D.O. No. 9//2020-NA dated 22.12.2020 of HMEFCC has not been submitted.
- (b) The State has included purchase of vehicles, maintenance of vehicles, POL and monitoring and supervision charges (12% of total cost of CA plantation). Similar provision has been included in respect of CATP, Wildlife Conservation Plan and Other Works, which may not be as per FCA norms.
- (c) Monies under head "Others" are to be utilized as site specific schemes submitted by the State along with approved proposals, but the State has treated these monies as NPV. Hence, these activities may not be approved.
- (d) Majority of the activities (Plantation, weeding, construction etc.) proposed are spilling over to the next FY 2021-22. Thus, it is an APO more for FY 2021-22 than the current year. Such activities are required to be excluded from the APO.

### Agenda Item No.7

No Cost Extension of the scheme "Endangered Species Recovery Programme (ERSP)" submitted by WII, Dehradun.

The Wildlife Institute of India, Dehradun vide their letter No.WII/TMP/CAMPA/GIB Project/2016/13 dated the 28<sup>th</sup> January, 2020 have requested for no cost extension of ERSP for a period of two years.

- 2. ERSP is an ongoing scheme initially approved by the National CAMPA Advisory Council (NCAC) with a total financial outlay of Rs.100.38 crore for a period of 5 years (2015-16 to 2020-21). The scheme was approved in the 1<sup>st</sup> meeting of the Governing Body of the National Authority. Till date total grant of Rs.37.22 crore has been released by the National Authority
- 3. The project has a significant impact on the recovery of the critically endangered species, namely Great Indian Bustard, River Dolphin, Dugong and Sangai. A no cost extension for another two years is necessary to complete the envisaged tasks which could not be completed due to COVID-19 and other logistical reasons.
- 4. The Agenda Item is placed for consideration of the 10<sup>th</sup> Executive Committee of the National Authority.
