# AGENDA ITEM NO. 6: ADDITIONAL ANNUAL PLAN OF OPERATION OF ASSAM STATE AUTHORITY FOR THE YEAR 2024-25

The Addl. Principal Chief Conservator of Forests and CEO, State CAMPA, Assam vide their letter no. FG.27/CAMPA/SLSC/2022 dated 19.11.2024 requested for approval of additional APO of ₹50.18 crore under "Others" head of Assam State Compensatory Afforestation Fund (SCAF) for the year 2024-25 for raising ₹6.34 crore seedlings for using in *Amrit Brikshya Andolan*, 2025 to encourage people of the State to grow more trees on their land and contribute to the growth of tree economy in the State. It comprises-

- i. Raising of 3.84 crore seedling in existing 52 nurseries with total estimated cost of ₹24.18 crore.
- ii. Raising of 2.5 crore seedlings in 36 new nurseries to be created with total estimated cost of ₹26.00 crore.

These seedlings are proposed to be used for plantation outside forest areas under *Amrit Brikshya Andolan*, 2025.

As submitted by the Assam State that *Amrit Brikshya Andolan* was started in the year 2023 with the aim to increase tree cover outside forest and wood-based economy in the State. Under *Amrit Brikshya Andolan* seedlings are planted outside forest areas involving public, SHG Members, ASHA Workers, Anganwadi Workers, VDPs, Institutions, Organization etc.to increase the green cover in the State. This aims to encourage the people of Assam to grow more trees on their own land. Under *Amrit Brikshya Andolan*, 2023 a total of 1.19 crore seedlings were planted and further during 2024, a total of 3.19 crore seedlings have been planted. It was informed by the CEO CAMPA Assam that all these planted seedlings are geo-tagged and photographs uploaded on a web portal meant specifically for this purpose.

In this regard, State was asked to furnish details of activities permitted under "Others" head and to confirm that proposed creation and strengthening of nurseries is covered under this head. Accordingly, the PCCF & HoFF Assam has clarified vide letter no. FG.27/CAMPA/Head/CAF Rules 2018/Pt-I dated 6<sup>th</sup> Dec, 2024 that following activities are permitted under "Others" head in Assam:

- i. TA/DA of the senior supervisory officers related to inspection of works.
- ii. Office maintenance and office expenses.
- iii. Purchase of vehicles and their maintenance.
- iv. Creation and maintenance of nurseries.
- v. Monitoring and Evaluation of CAMPA works.

#### **Decision of Executive Committee:**

Principle Chief Conservator of Forests Haryana State CAMPA letter vide no. 469 dated 6<sup>th</sup> November 2024 requested for rectification of soil and moisture conservation works approved under NPV in APO for the financial year 2024-25.

The Annual Plan of Operation for FY 2024-25 of Haryana was discussed in 31<sup>st</sup> meeting of Executive Committee. The EC has approved an amount ₹120.83 crore against the proposed target of ₹128.18 crore for carrying out approved activities for FY 2024-25.

Haryana State Authority vide their letter no. 469 dated 6<sup>th</sup> November informed that the in the integrated APO, the State had proposed ₹20.00 crore under Rule 5(2)g of CAF Rules, 2018, for the water bodies, because of which it had been approved for creation of waterbodies activity in the approval order communicated vide National Authority Letter No. NA-15/6/2020-NA dated 14<sup>th</sup> August 2024. However, the detailed APO (2024-25) specifies that these funds were allocated for SMC works, including abutment walls, check dams, masonry structures, wire structures, and studs. Further Haryana is requesting for rectification of activity approved under Rule 5(2)g of CAF Rules, 2018, in NPV component for FY 2024-25.

# AGENDA ITEM NO. 10: DIGITAL APO READINESS & APO PREPARATION FOR 2025-26

- 1. The Digital Annual Plan of Operation (APO), developed as part of the PARIVESH 2.0 portal is an initiative aimed at transforming the preparation and submission processes of APOs under CAMPA, bringing greater efficiency, transparency, and accountability. By integrating key forest proposal data directly from PARIVESH 2.0, the system reduces manual effort, eliminates redundancies, and ensures accuracy across all levels of administration.
- 2. The system follows a well-defined process flow:
  - i. The Divisional Forest Officers (DFOs) create and submit the APOs to their respective Circle Officer.
  - ii. Circle Officer review and approve them before forwarding them to the State CAMPA CEO.
  - iii. The State CAMPA CEO consolidates and finalizes the APOs before submission to National CAMPA for approval.
- 3. To support the transition to the new system, MoEFCC has put in place a robust support mechanism. A dedicated helpdesk has been established to address operational and technical issues faced by officials. Additionally, a complaint module has been integrated within the PARIVESH portal to log and monitor any challenges, ensuring quick resolution.
- 4. The Ministry remains committed to supporting all stakeholders through continuous engagement, training, and technical assistance to ensure the successful implementation of this transformative initiative.
- 5. Presently, digital APOs are in the advanced stage of adoption by various States/UTs to propose their APO for the FY 2025-26. The States/UTs have been requested to submit their APOs for FY 2025-26 before 31<sup>st</sup> December, 2024 as per Rule 39 of the Compensatory Afforestation Fund Management and Planning Authority.
- 6. As of now, the progress of Digital APO readiness has been encouraging. More than 500 divisions across the country have already begun filling their APOs for FY 2025-26 in the PARIVESH 2.0 portal.

# AGENDA ITEM NO. 13: ISSUE RELATED TO FLOW OF FUNDS WITH NATIONAL CAMPA

The Section 4 of the Compensatory Afforestation Fund Act, 2016 (CAF Act) provides that all monies realised from various User Agencies towards Compensatory Afforestation, Penal CA, Net Present Value, Catchment Area treatment plan and under various provisions of Wildlife protection Act (in lieu of the diversion of forest lands under the provisions of the Forest (Conservation) Act, 1980 now known as the Van Sanrakshan Evam Samvardhan Adhiniyam, 2023 should be credited into the State Fund maintained by State Compensatory Authority and then the ten percent of the amount should be transferred to National CAMPA fund by each State on yearly basis.

- 2. On the direction of Hon'ble Apex Court, Compensatory levies are realised from the User Agencies for Compensatory Plantation, Penal Compensatory Afforestation, Net Present Value (NPV), Catchment Area Treatment (CAT) etc from the user agencies. To manage these funds initially an adhoc-Compensatory Afforestation Fund Management and Planning Authority (adhoc-CAMPA) was constituted and all the fund received from various User Agencies in respective States and UTs in lieu of diversion of forest land was transferred to the Adhoc-CAMPA in 2009. Later, when CAMPA was constituted in 2016, all the fund available were transferred to the National CAMPA.
- 3. The National CAMPA is continuing with the existing procedure of depositing the receipt of compensatory levies realised from the user agencies in lieu of the diversion of forest lands under the provisions of the Forest (Conservation) Act, 1980 now known as the Van Sanrakshan Evam Samvardhan Adhiniyam, 2023 to Public Accounts channelizing through dedicated State/UT Specific Savings Bank Accounts maintained in the Union Bank of India for the following reasons:
  - a. The compensatory levies are linked with the process of approval of Forest Clearances accorded by the Ministry in accordance with the provisions of the Forest (Conservation) Act, 1980 now known as the Van Sanrakshan Evam Samvardhan Adhiniyam, 2023. The realisation of compensatory levies is required in compliance of the conditions of Stage-I clearance and only after the confirmation of this statutory requirement, Stage-II or Final approval for diversion of forest land is given by the Ministry.
  - b. The compensatory levies are realised for different projects from various user agencies under different components such as mandatory Compensatory afforestation, Integrated Wildlife Management Plan, Catchment Area Treatment Plan, NPV and others, which are to be utilised for different purposes and specific activities as per the provisions of the CAF Act and Rules.

Hence, in the initial stage, the reconciliation is essentially required for proper accounting and avoiding confusion at later stages, maintaining fiscal discipline & integrity of CAMPA funds and transparency in the process. To address proper reconciliation of the deposited compensatory levies, these amounts are initially provisioned to be routed through State Specific Bank Accounts as a purely temporary measure. After the project and component wise reconciliation, the State CAMPA Funds are transferred to the Public Accounts of the Union and from which to the respective States/UTs Public Accounts.

- 4. It is also to mention that the information on the receipt of Compensatory levies is one of the essential conditions of Stage-I approval to be complied by the User Agencies before seeking final approval of the Central Government. This deviation from the provisions of the CAF Act, 2016 & its Rules, 2018 was also brought before the Governing Body which has approved this financial arrangement in the 4th Meeting.
- 5. However, the Compensatory Afforestation Fund Act, 2016 and Rules, thereunder provide collection of compensatory levies by the States and UTs and then transfer 10% of the National CAMPA share to the National CAMPA. This provision has its limitations.
  - i. Firstly, it makes it difficult to reconcile the data of compensatory levies project proposal and Head-wise (CA, Integrated Wildlife Management Plan, Catchment Area Treatment Plan, NPV and others) and may lead to delay in processing of the forest diversion cases seeking second stage of FC clearances.
  - ii. Secondly, it has been noticed that many States are not following the fiscal discipline and delay release of funds to State Forest Department against the approved APOs for implementation of time bound and seasonal activities viz. compensatory afforestation and other CAMPA.
  - iii. Thirdly, State CAMPA as an institution has not properly evolved in many of the States/UTs to function as required by the CAF Act, 2016.
- 6. The PARIVESH 2.0 Portal is almost fully functional now with additional features. It is proposed that the Compensatory levies realized from User Agencies received through the Portal is instantly divided into 90% of the State Share and 10% of the National Fund share to be transferred immediately to concerned State/UT Government Public Account and to the Public Account of India respectively. This arrangement, apart from meeting the requirement of the CAF Act 2016, may also bring more efficiency and promptness in processing of forest clearance proposals.
- 7. The opinion of the Ministry of Law & Justice was sought as to whether the proposed arrangement of simultaneous transfer of National & State Share will amount to implementation of the CAF Act or some other arrangements are required to be made.
- 8. MoLJ during last week of October 2024 furnished legal advise that in the light of the provisions of the section 3 & 4 of the Compensatory Afforestation Fund Act, 2016 r/w Section 2(1), Central Government may make rules to manage and regulate National Fund as well as State Fund in consultation with the State Government, respectively. Since, there appears to be no substantial change in the scheme of the Act by the proposed arrangement, therefore, Central Government may regulate the procedure under Section 3 & 4 in consonance with the provisions of the Compensatory Afforestation Fund Act, 2016.

#### Short term objectives

- To assess the impact of annual thermal oscillation, precipitation pattern and edaphic factors on cone production in *Pinus gerardiana*.
- To determine the role of metabolic and gene regulation in induction of cones.
- To study the effect of exogenous application of growth regulators on cone formation and seed yield

#### Long term objective

 To develop strategies for regular seed production of Pinus gerardiana for its conservation and livelihood generation of tribal communities.

#### **Project Outcomes**

- The first objective will provide a comprehensive understanding of the critical temperature and precipitation condition during different annual reproductive and vegetative growth phase that affect Chilgoza cone and seed production.
- Key phytohormones involved in cone development will be identified, which can be targeted for managing and enhancing cone production.
- Transcriptome sequencing will reveal different gene expression during cone development, highlighting key gene regulatory network and candidate genes involved in this process.
- Identified gene regulatory networks and candidate genes can be targeted to improve cone and nut production.
- Through the study of exogenous phytohormones application, a strategy or protocol for the artificial regulation of cone and seed production in *Pinus gerardiana* will be developed.
- The outcomes will provide valuable knowledge and tools for enhancing cone and seed production in Chilgoza pine. This will ultimately promote the domestication of the species and uplift the livelihood of the tribal community in the region.

### AGENDA ITEM NO. 17.5 UTTARAKHAND STATE CAMPA SPILL OVER ACTIVITIES OF THE FINANCIAL YEAR 2023-24

Uttarakhand State CAMPA vide letter no. 565/GOI/ 2024-25 dated 22<sup>nd</sup> October 2024 has requested the approval of spill-over activities of ₹9.22 crore under Catchment Area Treatment Plans of site-specific activities as per Section 6(a) of CAF Act, 2016, in the APO of 2023-24.

- 2. The National Authority had approved a total amount of ₹383.82 crore against the proposed outlay of ₹423.46 crore for the financial year 2023-24. An amount of ₹69.42 crore was approved by the National Authority for implementing CAT plans in 2023-24. Of which, ₹65.99 crore was allocated to the implementing agencies against the budget released by the Uttarakhand State Govt, of which ₹16.29 Crore remained unspent. From the unspent balance, the Uttarakhand State CAMPA is requesting the approval of the balance of ₹9.22 Crore as spillover funding under the CAT plan for the current financial year (2024-25) to complete certain time-bound activities of critical projects.
- 3. In view of above-mentioned information, a meeting was held by National CAMPA on 18<sup>th</sup> November 2024 under the chairmanship of CEO, National CAMPA, where it was decided that Uttarakhand State Authority shall furnish the details about the circumstances under which the additional proposal of implementation of the CAT plan could not be incorporated in the Annual Plan of Operation 2024-25 as spill over activities of previous yea₹ The information on the same is yet to be received from Uttarakhand State Authority.

Outcomes	At present tiger reserves are getting support under Project Tiger and it is also managed as per the laid down Acts and rules in place however, the areas located outside umbrella of Project Tiger harbouring tigers are devoid of this additional assistance. Understanding the division-wise distribution of tigers outside tiger reserves provides valuable insights into their spatial distribution and is crucial for effective conservation planning. While resources and intensive protection efforts are focused within tiger reserves, developing site-specific, data-driven conservation strategies through training and monitoring outside these reserves is vital. The conservation planning for larger landscape would be a support for the long-term survival of tigers and co-predators, prevents man-animal conflict situation, promotes sustainable development, and preserves biodiversity and ecosystem health, ultimately benefiting both wildlife and local communities.						
	2. Further the dispersal of the Tigers from source area, (i.e. habitat that allows the populations to increase) to Sink area due to doubling of Tiger population in almost 68% of the Tiger landscapes in the last decade reportedly have Tiger presence outside Tiger Reserves. This calls for immediate attention to manage the situation thereby prevents the Human-animal conflict and also to protect the local communities and Wildlife rather creating another source area. The increase in Tiger population also leads to a situation wherein co-predators is pushed to peripheral area of the Tiger landscapes and in-turn leads to a conflict situation many a times. Hence management of areas outside Tiger reserves where Tiger presence and Co-predator is reported is really need of the hour so as to equip the staffs of Forest Divisions (Territorial divisions/wildlife divisions) similar to Tiger						



Reserve areas and also to develop a system so as to handle the situation in a strategic manner.

- 3. Out of 56 Tiger Reserves in 18 Tiger Range states, 38 Tiger Reserves have moderate to high density of Tigers wherein dispersal of Tiger outside Tiger Reserves is obvious and estimated during the All Tiger Estimation also. Based on the data collected from the states regarding areas reported Human-Tiger Conflict situation in the last 3 years and approximate number of divisions reported are of 80 numbers and 50 ranges (includes both Territorial and Wildlife Division) across the country which is of areas adjoining to such moderate to high density Tiger Reserves. Hence the Tiger utilizing landscapes adjoining to such moderate to high density Tiger reserves in around 10 states i.e. 80 Divisions (includes both Territorial and Wildlife Division) across the country is being focused in the initial phase as per the list enclosed.
- 3. The implementation of this project will help to reduce Human-tiger and Co-predator conflict issue in the areas outside Tiger Reserves due to continuous protection measures, monitoring which includes early warning system and by involving local communities.

**Decision of Executive Committee:** The EC appreciated the efforts and directed that Programme Division should check with Central Sector Scheme to avoid duplication of the work proposed. NTCA will consult Wildlife Division for their inputs.
