MINUTES OF 5TH MEETING OF THE GOVERNING BODY OF THE NATIONAL COMPENSATORY AFFORESTATION FUND MANAGEMENT & PLANNING AUTHORITY HELD ON 01.08.2024

The 5th Meeting of the Governing Body was held under the Chairmanship of the Hon'ble Union Minster of Environment, Forest & Climate Change (HMEF&CC) and Chairman, Governing Body of National Authority. The list of the members and other participants who attended the meeting is attached at **Annexure-A.**

- 2. The Chief Executive Officer (CEO) of the National Authority welcomed the HMEF&CC, Chairperson of the Governing Body, Hon'ble Minister of State, EF&CC, Secretary, EF&CC, DGF&SS and all other members of Governing Body present in the meeting.
- 3. With the permission of the Chairman, agenda items for the meeting were taken up for detailed discussion.

AGENDA ITEM NO.1: CONFIRMATION OF MINUTES OF 4th MEETING OF GOVENRING BODY OF NATIONAL AUTHORITY HELD ON 29.12.2023

The CEO, National Authority for confirmation by the Governing Body, placed the minutes of 4th meeting of Governing Body. He informed that the minutes were circulated to the members vide this office letter no. NA-5/10/2022-NA dated 10.01.2024 and no comments were received.

Directions and Decisions: The minutes of 4th meeting of Governing Body was confirmed by the Governing Body.

AGENDA ITEM NO.2: ACTION TAKEN REPORT (ATR) ON THE ACTIONABLE POINTS OF THE DECISIONS TAKEN IN THE 4th MEETING OF GOVERNING BODY OF NATIONAL AUTHORITY

The action taken report on the actionable points on the decisions taken in the 4th meeting of Governing Body of National Authority was presented. The details of deliberations and decisions on them are as follows:

2.1. Status of reconciliation of project wise Compensatory Afforestation since 1980 carried out against each forest land diversion proposal:

(i) The CEO, National Authority informed that the reconciliation of data on compensatory afforestation created against each forest land diversion proposal since 1980 was initiated for ensuring compliance of the terms and

conditions of Forest Conservation—approvals accorded by the Central Government. The sites for compensatory afforestation and other mandatory activities—like Catchment Area Treatment Plan, Integrated Wildlife Management Plan etc. are decided at the time of according approval for diversion of forests. Therefore, ensuring timely completion of these site-specific mandatory activities is necessary. It is also necessary to ensure that the compensatory afforestation is done on the sites already specified and approved while according the approvals by the Central Government for non-forestry use of forestland under the provisions of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. In case of any change from the approved site of compensatory afforestation or any other mandatory activity, the approval of the Competent Authority (Central Government) is essential.

- (ii) The CEO, National Authority informed that the reconciliation of CA data has been furnished by 23 States/UTs- Andaman & Nicobar, Assam, Arunachal Pradesh, Chandigarh, Chhattisgarh, Delhi, Goa, Gujarat, Haryana, Jharkhand, Jammu & Kashmir, Karnataka, Kerala, Maharashtra, Madhya Pradesh, Meghalaya, Odisha, Rajasthan, Tamil Nadu, Telangana, Tripura, Uttar Pradesh and West Bengal to respective Regional Offices for vetting. Project wise CA data has been vetted by the Regional Offices of the Ministry for four State namely Rajasthan, Jammu and Kashmir, Odisha & Uttar Pradesh. The reconciliation exercise in the remaining 09 states /UTs is in progress.
- (iii) The CEO, National Authority further informed that the data on forest land diversion and sites of compensatory afforestation and other mandatory activities is integral part of the forest diversion proposal furnished by the State to the Ministry for according its approval. The data is available with the Regional Offices as well as Forest Conservation Division of the Ministry. The Executive Committee of National Authority in its 31st meeting held on 16.07.2024 decided that the Regional Officers should ensure complete reconciliation of data on diversion of forest land and corresponding compensatory afforestation alongwith relevant details expeditiously for ensuring compliance of the mandatory conditions of approvals.

Decision of the Governing Body:

- (1) HMEF&CC desired that the Regional Offices of the Ministry and the concerned States/UTs should segregate the list of compensatory afforestation not yet started against the forest diversion proposals approved in three categories since (i) more than 10 years, (ii) more than 5 years upto 10 years and (iii) less than 5 years for having clarity on the progress of CA.
- (2) Further, the information on compensatory afforestation carried out vis-a-vis diversion of forest land should also be compiled in two categories (i) for the last 10 years (2014-2024) and (ii) the period since 1980 to 2014.

2.2. Timely release of funds to the State Forest Departments: The CEO, National Authority informed that there has been significant improvement as far as release of funds by the State Government to the State Forest Departments for carrying out CAMPA activities is concerned. The matter is pursued with the State/UT Governments regularly for further improvement.

Directions and Decisions: The Governing Body expressed concern over the delay in release of CAMPA funds, since timely release of funds is necessary for ensuring compliance of the mandatory condition of forest diversion approvals granted by the Central Government. It was decided that the States/UTs Governments should be impressed upon for timely release of CAMPA funds for effective and qualitative implementation of CAMPA activities.

2.3. Status of Development of Model Nurseries: The CEO, National Authority informed that during last two years National Authority has approved for creation of 973 Model Nurseries under APOs of the States/UTs.

Decision of the Governing Body: Hon'ble Minister desired that States/UTs should plan in advance for raising saplings of local tree species in the nurseries to meet the requirement of people under the tree plantation campaign "Ek Ped Maa Ke Naam".

Hon'ble Minister advised that the Member of Parliaments, Member of legislative Assembly, representatives of Panchayati Raj Institutions of the area may also be consulted while assessing the requirement of saplings for the campaign to be raised in the Modern Nursery. Self Help Groups may also be involved in the process. The Secretary, EF&CC may convene a meeting with the States/UTs for planning of the plantations under the campaign for the next year plantation season.

- **2.4. Status of C&AG Audit of National CAMPA**: The CEO, National CAMPA informed the Governing Body that:
- (i) C&AG Audit of the Annual Accounts of National CAMPA for the Financial Year from 2018-19 to 2022-2023 has been completed and certified.
- (ii) The Audit for the Financial Year 2023-24 has been conducted and Audit Report is awaited.
- (iii) Further, C&AG Audit Team also collected information from National Authority during the Performance Audit of Green India Mission. The Audit Report is awaited.

Decision: The Governing Body noted the status of C&AG Audit.

2.5. Update on the Mission MISHTI: CEO, National Authority informed that provision of Rs 100.00 crore for five years has been made under Mission MISHTI. During first year of implementation of Mission MISHTI, Rs. 12.54 crore has been released till date to the States/ UTs of Gujarat, Kerala, Puducherry and West Bengal. In addition, Mission MISHTI is being implemented through State CAMPA Funds and convergence with other Schemes.

Decision: The Governing Body noted the status. Hon'ble Minister desired a report on the status the progress made in mangrove plantation in the coastal region of Gujarat at Sir Creek's area and Somnath temple from PCCF of Gujarat. The PCCF Odisha was urged to inform status of mangrove plantation at Bhitarkanika and Chilika Wildlife Sanctuary.

2.6. Update on Nagar Van: The CEO, National CAMPA informed that 471 Nagar Van have been approved and Rs 336.26 Cr has been released till date. IGF, NAEB informed that the 129 number of fresh and complete proposals for establishment of Nagar Van from States/UTs have been received out of which 35 Nagar Van has been approved and the remaining are in process.

AGENDA ITEM NO. 4: INITIATIVES OF NATIONAL CAMPA

(i) CAMPA Support to Mission MISHTI

CAMPA is supporting restoration, conservation and management of mangroves across the Country by providing funds to forest departments of coastal States and Union Territories. CAMPA has kept a provision of Rs. 100.00 crore during first year of implementation of Mission MISHTI, a five-year conservation programme for eleven coastal States and two Union Territories.

Decision: The agenda item was noted by the Governing Body.

(ii) CAMPA Support to Nagar Van Yojana

National Afforestation and Eco-development Board is implementing Nagar Van Yojana (NVY) since 2020 which envisages developing 1000 Nagar Vans/Vatikas in the country during the period of 2020-21 to 2026-27. National Authority has released Rs. 336.03 crore for development of 471 Nagar Vans/Vatikas till date.

Decision: The progress of development of Nagar Van in various States was noted.

(iii) CAMPA Support to Green Credit Scheme

CAMPA support for Green Credit Scheme (HSM Division & ICFRE). Green Credit Programme promote activities for increasing the green cover across the country through tree plantation and related activities. To promote sectoral level water conservation, water harvesting and water use efficiency/savings, including treatment and reuse of wastewater. National Authority has released Rs. 6.28 crore to ICFRE till date.

Decision: The progress of Green Credit Scheme was noted.





i. Of the scheme, Component 1 has 31 All India Coordinated Research Projects (AICRPs) which includes 13 Species based and 18 Theme based research projects. These projects got initiated during February, 2020 but the beginning of the projects coincided with the unprecedented situation arisen due to the PANDEMIC (COVID-19). As majority of the projects involved field activities like surveys, population identification, collection of data on maturity indices, collection of seed, site selection for field trials etc. adversely got impacted due to travel restrictions imposed by different state governments from time to time during 2020-2021 and 2021-2022. This resulted in affecting the progress of research projects. The establishment of field trials for which site selection was planned to be carried out in the first year, resulted

Intral -

- in late establishment of field trials and hence, subsequent recording of growth parameters also got delayed.
- ii. The pandemic emergency not only restricted the field operations but also affected the office working and hampered the fund flow for the scheme during 2020-2021 and 2021-2022 as the budget was not released on yearly basis as approved in the sanction order but in instalments.
- iii. Of the other five components, the Component 4 (REDD+) which involved capacity development programme for stakeholders was completed by organizing mostly ONLINE trainings on REDD+ for the SFD personnel of all the states of the country during pandemic time. The various activities under Component 2 (FGR), Component 3 (CFPR), Component 5 (HRD) and Component 6 (FES) are yet to be completed.
- iv. In view of the above facts, it would be difficult to complete the envisaged activities of the scheme under different components including many AICRPs to arrive at conclusive results and give recommendations.

Recommendation of Executive Committee: The EC expressed concern on the slow progress of the Scheme. This is a very important Umbrella Scheme aiming at ecological sustainability, quality of forests and enhancement of forest productivity. The EC advised the Programme Division to review the Progress with ICFRE and make concerted efforts to include other similar important research projects in this Umbrella Scheme for overall improvement of the quality of forests, biodiversity and productivity of tree plantations. If required, the Scheme can continue as a long-term umbrella Research Programme of the ICFRE. The ICFRE should also focus on proper extension and publicity of the research outcomes to stakeholders for adaptation in the field.

The EC recommended for no cost extension to the project upto 31.03.2026 on the recommendation of RT (Programme) Division. The EC desired that the Programme Division should monitor the Research outcomes achieved so far and place a comprehensive report in the next EC meeting. Also, the Executive Committee did not recommend institutional charge and any foreign visit by any official/ scientist using the National CAMPA Fund for this Scheme/Project.

National Authority has transferred an amount of Rs. 11,236.22 crore reconciled upto the period 2021-22 to 33 States/ UTs during 2023-24. The reconciliation of funds for 32 States/ UTs for an amount of Rs. 5,857.66 crore (Rs. 5,271.89 crore as State/UT Share and Rs. 585.77 crore as National Share) have been done for the period 2022-23 leaving the UT of Dadra Nagar Haveli, Daman & Diu who have not yet sent the component-wise details to National Authority for reconciliation.

As per decision taken in the 4th Meeting of the Governing Body, the State/UT share is to be transferred to those States/ UTs who have credited the interest accrued on their respective State/ UT CAMPA Funds. In this regard, only 11 States have credited accrued interest on CAMPA Funds and accordingly their State share has been transferred upto 2022-23. The total State share transferred to State & UTs is Rs. 2,339.57 crore and the National Share is Rs. 259.95 crore.

Efforts are made to transfer remaining State share of CAMPA funds to respective States/Union Territories upto the financial year 2023-24 after reconciliation. The process of reconciliation of compensatory levies project wise and head wise in consultation with the States/ UTs is in progress

Presently as at 31.3.2024, there is a balance of Rs. 9574.34 crore under Major Head- 8121 (10% portion i.e. National Fund) and Rs. 18,061.60 crore under Major Head- 8336 (All States Accounts) in Public Account of India as per Balance Sheet of National Authority.

Decision of Governing Body: The Governing Body noted the provisional accounts of National CAMPA for 2023-24 and directed to place the Accounts after the receipt of the audit certificate.

AGENDA ITEM NO: 8.1: ENGAGEMENT OF PROFESSIONAL MANPOWER IN NATIONAL AUTHORITY ON CONTRACUAL BASIS

1. The Executive Committee approved following professional manpower requirement for strengthening National CAMPA in its 22nd meeting held on 31.03.2023:

ii. National CAMPA Monitoring & Evaluation Team (NMET):

- 2. The National Authority approves schemes and pilot projects under section 5 (iii) (b) of the CAF Act, 2016, for the pilot schemes of forest and wildlife sector. As per the procedure being followed, an institute, society, centre of excellence in the field of forest and wildlife submits a proposal for implementation of a pilot schemes related to forestry and wildlife sector to the concerned Division (Programme Division) of the Ministry. On receipts of such proposals in National Authority from the concerned Programme Division, the proposals/ schemes are scrutinized and placed in the form of Agenda Note before the Executive Committee. After obtaining the recommendation of Executive Committee, the proposal is placed before the Governing Body for its approval.
- Total 53 schemes being implemented out of National funds in various institutes e.g. ICFRE, WII, FSI, HFM. Now, additional schemes are under process of approval by the Governing Body. Thus, taking into account the gradual increase in work of the National CAMPA, additional manpower i.e. one dedicated consultant (Forestry & Wildlife) is urgently required.
- 4. Two websites viz-National CAMPA website and portal for Digital APO are under process of development, which are at the verge of completion. After the launch of the same, for day to day a Consultant (CS/II) would be required. Further, previously, 10 position of Young Professional were sanctioned in the 22nd Meeting of the Executive Committee and was concurred by IFD. Currently, with the increased work, 5 more Young Professional in the field of Commerce, Accounting, Management & Administration, Computer Science and IT would also be required.
- 5. The estimated financial implication for engagement of additional, professional manpower is tabulated below:

AGENDA ITEM NO. 8.2. OUTSOURCING/ ENGAGEMENT OF STAFF IN THE NATIONAL AUTHORITY CAMPA

National CAMPA has initiated many innovative practices for systematic improvement in the overall functioning of the Authority. Some of these are development of Website, Digital APO portal, Management Information System for the Schemes supported from National fund. National CAMPA is also working to make the cash flow of CAMPA funds more efficient and effective.

2. The official CAMPA website as a single window access to various CAMPA works is under development (in-house) since Nov, 2023. A short-term engagement of technical man power for IT, programming, testing and maintenance support of the website is proposed for its efficient and smooth functioning on the NIC server.

Similarly, services of Legal Advisor/Expert, CA/CSs, Finance& Accounts experts, technically qualified manpower's in the field of GIS/MIS. Forestry Research etc were required time to time in National CAMPA.

- 3. It is proposed that on short term requirements of National Authority, the service provider shall provide additional/ technically qualified manpower's in the field of GIS/MIS, Forestry Research, IT, Website development, Programming, Legal, Accounts & Finance Expert, and CA/CSs etc. at the remuneration decided by the CEO, National CAMPA Authority. The vendor/service provider is eligible to charge approved profit margin to the extent of agreed quantum.
- 4. The estimated financial implication for short-term engagement (less than three month) of technical manpower is tabulated below-
