**Sub: Transfer of CAMPA funds as per the provisions of CAF Act, 2016 in compliance of the Supreme Court Order dated 28.01.2019 – reg.**

Sir,

With reference to above subject, it is submitted that the CAMPA funds in respect of UT of Chandigarh have not yet been released by the National CAMPA Authority. In this regard, you may kindly recall the meeting with the Conservator of Forests, Chandigarh Administration in your office on 17.12.2019 wherein it was stated that in respect of UT Chandigarh, the State Fund Notification was not appropriate. After looking into our office records, it was understood that the Sub-Head/Minor Head was not provided in the Notification dated 11.02.2019. This was subsequently corrected vide Chandigarh Administration Notification dated 13.06.2019. Copy of both the Notifications are attached herewith for your kind reference.

In view of above, the observations of the National-CAMPA Authority have already been complied with. It is pertinent to mention here that the Annual Plan of Operation (APO) for the current year 2019-20 in respect of UT Chandigarh has been duly approved by National-CAMPA Authority, however, the field works are getting affected due to lack of funds in the CAMPA account.

Therefore, it is once again requested that the amount due to UT Chandigarh be released at the earliest so that the field works may be taken up on priority.
