**ORDER**

As per Section 4(1) of The Compensatory Afforestation Fund Act, 2016 of the Government of India there shall be established a special Fund to be called the 'State Compensatory Afforestation Fund Kerala under the Public Account division of the State Government. Further, Section 4(2) of the Act provides that the State Fund shall be under the control of the State Government and shall be managed by the 'State Compensatory Afforestation Fund Management and Planning Authority'. Accountant General as per letter read as 1st Paper above has furnished State specific accounting procedure for the State Compensatory Afforestation Fund. The Accountant General has also requested the State Government to open necessary Sub Heads under the Heads of Account 8336-103, 8121-129, 2406-04-103, and a minor head under 2406-04 in the State Accounts to record the transactions as per the Accounting Procedure stipulated under State Compensatory Afforestation Fund.

Sanction is accorded for the opening of new head(s) of account as shown in Column No.(2) below under the existing head(s) of account shown in Column No.(1) in the Demands for Grants and Detailed Budget Estimates /Detailed Estimates Under Debt Heads, 2018-19.
