NOTIFICATION

In compliance to the provision of section 4 of Compensatory Afforestation Fund Act, 2016 and Compensatory Afforestation Fund Rules, 2018 and communication F.No.11-100/2015-FC(Vol.III) dated 16.08.2018 and even F.No.11-100/2015-FC(Vol.III) dated 28.01.2019 of Ministry of Environment, Forests & Climate Change (FC Division) New Delhi and in accordance with the concurrence issued by the Accountant General (A&E), Tripura vide letter No.TMC/New Head of Account/2018-19/1540 dated 12/03/2019 and even No. 746/Government Accounts/62-2017-H dated 23/08/2018 of Comptroller & Auditor General of India, New Delhi, the Government of Tripura is hereby establishes a special Fund called "State Compensatory Afforestation Fund- Tripura" referred as 'State Fund'.
