With reference to the above subject and in continuation of point no. 3 of referred letter, regarding creation of State Fund, I would like to inform that the State of Uttarakhand has successfully created the State Fund in the name of "Uttarakhand Compensatory Afforestation Fund" vide Govt. of Uttarakhand notification no. 1010/X-4-18/3(02)/2018 dated 28 September, 2018 (copy enclosed) under section 4(1) of the Compensatory Afforestation Fund Act, 2016.

2. Accordingly, as per section 1 of the Draft Accounting Procedure notified on 17 August, 2018, specific heads have also been opened in the State of Uttarakhand for transfer/deposit of funds from National Authority.
