I am directed to refer to letter No.F.(A)PO 2020-21/CAMPA/PCCF/4843 dated 11th August, 2020 of the Government of Rajasthan on the above-mentioned subject and to convey the approval of the Executive Committee of the National Authority under Section 15 (1) (i) of the Compensatory Afforestation Fund (CAF) Act, 2016 for the Supplementary Annual Plan of Operation-Rajasthan (2020-21) at a total cost of ₹ 65.34 crore (Rupees sixty-five crore and thirty four lakh only) out of the proposed outlay of ₹ 65.34 crore recommended by the State Steering Committee for carrying out approved activities during the current financial year from the "State Compensatory Afforestation Fund-Rajasthan" created under Section 4 of CAF Act, 2016.
