Sub: Additional Annual Plan of Operation for 2020-21 of Rajasthan State CAMPA: sanction for spill over activities regarding GIB Conservation works in Desert National Park, Jaisalmer, during 2021-22.

Sir/Madam,


I am directed to refer to letter No. F.14(2)/CAMPA/APCCF/2021-22/4933 dated 24.08.2021 of CEO, Rajasthan CAMPA on the above mentioned subject and to convey the approval of the Executive Committee of the National Authority under section 15 (1) (i) of the Compensatory Afforestation Fund (CAF) Act, 2016 for carrying out spill over works of the Additional Annual Plan of Operation – Rajasthan (2020-21) at a total cost of Rs.265.78 lakh (Rupees two hundred sixty five lakh and seventy eight thousand only) during the current financial year from the “State Compensatory Afforestation Fund – Rajasthan” created under Section 4 of CAF Act, 2016.

2. The Executive Committee of National Authority in its 8th meeting held on 25.08.2020 had approved the Additional APO for 2020-21 that also included mandatory activities regarding GIB Conservation works in Desert National Park, Jaisalmer, Rajasthan at the total cost of Rs 275.00 lakh. However, the State could spent only Rs 9.22 lakh on these activities during 2020-21.

3. The Executive Committee of National Authority in its 15th meeting held on 20.10.2021 has approved the spill-over activities for its implementation during current financial year.

4. The approval is subject to conditions mentioned in letter of even number dated 15th July 2020.
