Kindly refer your letter no. PS/PCCF/977 dated 16th January, 2024 and letter no.819 dated 29/01/2024 of CEO CAMPA, Haryana seeking clarification regarding amount sanctioned/approved for maintenance works under Compensatory Afforestation (CA) 2310.82 hectares on the approved sites and maintenance of 3965.78 hectares plantations on the unapproved sites in this regard, it is to clarify that vide NA-15/6/2020-NA dated 21st Sep. 2023, an amount of Rs 49.43 crore was approved out of which Rs. 29.89 crore was approved specifically for the Compensatory Afforestation (maintenance of existing/older plantation). Further based on the information furnished by the State Authority of Haryana vide their letter no. 721 dated 02<sup>nd</sup> November, 2023; and consequently, as per decision taken in the 26<sup>th</sup> meeting of EC Rs. 20.60 crore was approved with the remarks "Approved as per actual and limited to proposed out lay further excluding the area which were approved by Central Government in accordance with FCA 1980" and Rs 10.00 crore was approved towards maintenance of Artificial regeneration vide sanction letter of this authority dated 14th December, 2023.

In addition to above, an amount of Rs. 10.00 crore for the Soil and moisture conservation works was approved vide letter no. NA-15/6/2020-NA dated 03<sup>rd</sup> January, 2023.

Therefore, total sanction accorded to the State Authority of Haryana towards Annual Plan of Operation for year 2023-24, is Rs. 69.02 crore (Rupees Sixty-nine crore and two lakh only). The total sanctioned amount is given as under:
