Sub: Approval of deferred items in Annual Plan of Operation for the year 2023-24 of Uttar Pradesh State CAMPA regarding "Establishment, maintenance of Animal Rescue Center and Veterinary Treatment facilities for wild animals".

Sir,

The proposal was earlier discussed in the 22nd & 23rd meetings of Executive Committee while considering Annual Plan of Operations furnished by State CAMPA of UP and was deferred these items for want of certain details. The CEO, UP State CAMPA has clarified that the CAF Rule 5(2) (k) provides for "Establishment, maintenance of Animal Rescue Center and Veterinary Treatment facilities for wild animals" and the work was approved by CZA for Meerut, Pilibhit Tiger Reserve, Ranipur Tiger Reserve, Chitrakoot and Sohagibarwa Wildlife Division, Maharajganj. The CZA vide letter dated 23.03.2022 has also subsequently approved the use of CAMPA budget for establishment of Rescue Centres.

2. The deferred item was placed before the 28th meeting of Executive Committee. After considering the clarification given by the PCCF & HoFF Uttar Pradesh, the Executive Committee approved the deferred item of establishment, maintenance of Animal Rescue Center and Veterinary Treatment facilities for wild animals in Meerut, Pilibhit Tiger Reserve, Ranipur Tiger Reserve, Chitrakoot and Sohagibarwa Wildlife Division, Maharajganj, as per details given below:


