Sir,

The APO of Andhra Pradesh State Authority was deliberated in 29th and 30th meeting of Executive Committee (EC) of National Authority. The EC had approved an amount of **Rs. 248.37 crore (Rupees Two hundred forty eight crore and thirty seven lakh only)** for carrying out CAMPA activities so far.

2. On receipt of the request received from Andhra Pradesh State CAMPA Authority vide at S.No. 1 above referred for approval of additional amount for purpose of protection activity was placed before Executive Committee (EC) of National Authority in its 32nd meeting after deliberation on the related agenda , approval of an addition amount of **Rs. 5.23 crore** is conveyed by National authority.

3. With this approval total amount approved by National CAMPA would cumulatively be **Rs. 253.60 crore (Rupees Two hundred fifty three crore and sixty lakh only)** against the proposed outlay of **Rs. 258.67 crore**.
