Sir,

The CEO, Uttarakhand State CAMPA has informed vide his letter dated 22.01.2025 cited above that NHAI has deposited Rs. 3.7446 crores for Eco restoration works related to construction of National Highway-72 A section from Ganeshpur to Dehradun by the NHAI.

2. National CAMPA has vide letter dated 01.07.2024 (Referred at serial no. 1) already approved the activity proposed in the APO of 2024-25 for an amount of Rs. 7.90 crore for implementation of the proposed activities under Shivalik Integrated Eco-restoration Project (NH-72 A Ganeshpur - Dehradun) subject to transfer of funds by UP State CAMPA since funds against the project were not available with State CAMPA.

3. Since the amount of Rs. 3.7446 crore has been received by Uttarakhand State CAMPA from NHAI, the implementation of the Eco-restoration project should be taken up. The Uttarakhand State Government should pursue with the Government of Uttar Pradesh for transfer of funds earmarked for Uttarakhand at the earliest.
