The Annual Plan of Operation for the financial year 2024-25 of Maharashtra was considered in 28<sup>th</sup> & 30<sup>th</sup> meeting of Executive Committee (EC). During the meeting of Executive Committee of the National Authority considered and approved an amount of **₹720.32 crore**, and communicated vide letter no. NA-15/18/2020-NA dated 23<sup>rd</sup> April, 2024, 1<sup>st</sup> July, 2024 and 23<sup>rd</sup> September, 2024. Maharashtra State Authority submitted request for approval of additional APO of **₹10.33 crore** under the mandatory activity of the Compensatory Afforestation (CA) for the year 2024-25 received on 13.12.2024.

2. Additional Annual Plan of Operation 2024-25 of Maharashtra State CAMPA was discussed in details by the Executive Committee of the National Authority during the meeting of 33<sup>rd</sup> Executive Committee held on 18.12.2024. The EC approved additional amount of **₹10.33 crore (Rupees Ten crore and thirty three lakh only)** with this approval total amount approved by National Authority would cumulatively be **₹730.65 crore (Rupees Seven hundred thirty crore and sixty five lakh only)**.
