Sir,

The Annual Plan of Operation of Uttarakhand State CAMPA for the financial year 2024-25 was considered in 28th, 29th, 30th and 33rd meetings of Executive Committee. During these meetings, the activities were approved for an amount of ₹335.37 crore (Rupee three hundred and thirty-five crore and thirty-seven lakh only) against the proposed outlay of ₹408.00 crore (Rupees four hundred and eight crore only) by the National Authority.

- 2. Uttarakhand State CAMPA has requested National CAMPA to consider the spill-over activities of the APO 2023-24 vide their letter dated 22nd October 2024 and 16th December 2024 (Ref. 2 & 3). The request was placed before Executive Committee as an agenda item in its 33rd meeting held on 18 December 2024. The Executive Committee accorded approval for an amount of ₹9.2213 crore (Rupees nine crore twenty-two lakhs thirteen thousand only) in respect of spill-over activities for the financial year 2023-24. Thus the cumulative outlay approved by National CAMPA during financial year 2024-25 would be ₹344.59 crore (Rupees three hundred forty-four crore and fifty-nine lakh only) including the spill-over activities.
