**Sub: Approval of Additional Annual Plan of Operation for the financial year 2024-25 of Assam State CAMPA- reg.**

Ref: . Assam's letter no. FG.27/CAMPA/SLSC/2022 dated 19th November, 2024

Sir,

With reference to the letter dated 19.11.2024 of Assam State CAMPA regarding approval of Additional APO of ₹50.18 crore under the Head "Others" of Assam State Compensatory Afforestation Fund (SCAF) for the year 2024-25 for raising ₹6.34 crore with following proposals:

**Item No.1.** Raising of 3.84 crore saplings in existing 52 nurseries at estimated cost of ₹24.18 crore.

**Item No. 2.** Raising of 2.5 crore saplings in 36 new nurseries at estimated cost of ₹26.00 crore.

2. The Executive Committee (EC) approved the proposal at **Item No. 1** of above for upgradation of existing nurseries for strengthening capacity for raising of saplings for ₹24.18 crore. **Item No. 2** may be taken up from the State Funds. The State Government will ensure that the work proposed is covered as an approved activity under the Head "Others".

3. The EC noted that the State Government has not credited Interest accrued on State CAMPA Funds so far thereby limiting the availability of State CAMPA Fund. The State should ensure that the credit of accrued interest is done before submission of Next Year APO to National CAMPA.

4. The approval is subject to the same terms & conditions as communicated vide letter no. NA- 15/7/2020-NA dated 6<sup>th</sup> August, 2024. All wage payments should be made through Direct Benefit Transfer (DBT).
