
Sir,

In partial modification of the National Authority's letter no. NA-15/18/2020-NA dated 1st July, 2024 on the subject cited above conveying approval accorded by National Authority during financial year 2024-25 for an amount of Rs. 720.82 crore (Rupees seven hundred twenty crore and eighty two lakhs only) against the proposed outlay of Rs. 784.81 crore.

2. In the same approval an amount of Rs. 0.50 crore for activity hiring of staff cars for the use of the officers and officials as per 6 (b)iii CAF Rule, 2018 may kindly be treated **not** approved/deleted as this was inadvertently repeated (Page no. 2 Table A & S.No. 4), the amount Rs. 161.75 crore is now revised to Rs. 161.25 crore.

3. Therefore, now revised amount stand for Rs. 720.32 crore (Rupees seven hundred twenty crore and thirty two lakhs only) against the proposed outlay of Rs. 784.81 crore (Page no. 1 & para 2).
