The Annual Plan of Operation of Haryana State CAMPA for the financial year 2025-26 was considered in 35th meeting of Executive Committee of the National Authority held on 4th July 2025, in which the activities/works were approved for an amount of **Rs. 158.79 crore** (Rupees one hundred and fifty-eight crore seventy-nine lakh only) by the Executive Committee. Some of the remaining deferred items were considered by the Executive Committee of the National Authority in its 36th meeting, which was held on 9th October 2025, where an additional amount of **Rs. 33.53 crore** (Rupees thirty-three crore and fifty-three lakh only) has been approved for the deferred activities for the financial year 2025-26.

2. After due deliberations during 35th and 36th meeting, the total approval given by the Executive Committee of National Authority is conveyed under section 15 (1) (i) of the Compensatory Afforestation Fund Act, 2016, for the Annual Plan of Operation 2025-26 of Haryana State CAMPA for an amount of **Rs. 192.32 crore** (Rupees one hundred ninety-two crore and thirty-two lakh only) against the proposed outlay of **Rs. 225.78 crore** (Rupees two hundred and twenty-five crore and seventy-eight lakh only) for carrying out approved activities.


