Sir,

The Annual Plan of Operation of Tamil Nadu for the financial year 2025-26 was considered in 34th and 35th meeting of Executive Committee of the National Authority held on 23rd April, 2025 and 4th July, 2025 respectively, in which the activities/works were approved for an amount of **Rs. 22.82 crore** (Rupees twenty-two crore and eighty-two lakh only) by the Executive Committee. Some of the remaining deferred items were considered by the Executive Committee of the National Authority in its 36th meeting, which was held on 9th October, 2025, where an additional amount of **Rs. 0.64 crore** (Rupees sixty four lakh only) has been approved for the deferred activities.

2. After due deliberations during 34th, 35th and 36th meeting, the total approval given by the Executive Committee of National Authority is conveyed under section 15 (1) (i) of the Compensatory Afforestation Fund Act, 2016, for the State Annual Plan of Operation 2025-26 of Tamil Nadu for an amount of **Rs. 23.46 crore** (Rupees twenty-three crore and forty-six lakh only) against the proposed outlay of **Rs. 26.91 crore + Rs. 74.40 crore (sought from National Funds for sub judice matter) which is equal to Rs. 101.31 crore** for carrying out approved activities.


