The Annual Plan of Operation of Telangana for the financial year 2025-26 was considered in 35th meeting of Executive Committee of the National Authority held on 4th July, 2025, in which the activities/works were approved for an amount of **Rs. 375.98 crore** (Rupees Three hundred seventy-five crore and ninety-eight lakh only) by the Executive Committee. Some of the remaining deferred items were considered by the Executive Committee of the National Authority in its 36th meeting, which was held on 9th October, 2025, where an additional amount of **Rs. 36.91 crore** (Rupees Thirty six crore and ninety one lakh only) has been approved for the deferred activities.

2. After due deliberations during 35th and 36th meeting, the total approval given by the Executive Committee of National Authority is conveyed under section 15 (1) (i) of the Compensatory Afforestation Fund Act, 2016 for the State Annual Plan of Operation 2025-26 of Telangana for an amount of **Rs. 412.99 crore** (Rupees Four hundred twelve crore and ninety nine lakh only) against the proposed outlay of **Rs. 451.25 crore** (Rupees Four hundred fifty-one crore and twenty-five lakh only) for carrying out approved activities.

3. The details of component wise activities considered in 36th EC are as follows:


