The Annual Plan of Operation of Mizoram CAMPA for the financial year 2025-26 was considered in 34th & 35th meeting of Executive Committee of the National Authority held on 23rd April 2025 and 4th July, 2025, respectively, in which the activities/works were approved for an amount of **Rs. 3.86 crore** (Rupees Three crore and eighty-six lakh only) by the Executive Committee against the proposed outlay of **Rs. 3.86 crore** (Rs. Three crore and eighty-six lakh only). The Additional Annual Plan of Operation (2025-26) of Mizoram was considered by the Executive Committee of the National Authority in its 36th meeting, which was held on 9th October 2025, where an amount of **Rs. 17.42 crore** (Rupees Seventeen crore and forty-two only) has been approved for the financial year 2025-26.

2. Now the total approval given by the Executive Committee of National Authority conveyed under Section 15 (1) (i) of the compensatory Afforestation Fund Act, 2016 for the State Annual Plan of Operation 2025-26 of Mizoram State CAMPA is **Rs. 21.28 crore** (Rs. Twenty-one crore and twenty-eight lakh only) against the proposed outlay of **Rs. 21.28 crore** (Rs. Twenty-one crore and twenty-eight lakh only) including **Rs. 17.42 crore** (Rs. Seventeen crore and forty-two lakh only) for Additional APO (2025-26).
