

## Monitoring Mechanism adopted by Tripura CAMPA

**A.** The Principal Accountant General (Audit), Tripura periodically audits the accounts of the Tripura CAMPA. The auditing of the accounts of Tripura CAMPA is completed up to the FY 2020-21. (The AG audit reports up to the FY 2020-21 have already been sent to the National Authority).

**B.** The Forest Department is monitoring the activities regularly through field visit of senior officers, review meetings with the Field Officers as well as with the frontline staffs. The inspection notes of different CAMPA Activities as submitted by the higher officials of the Tripura Forest Department have been sent to the National CAMPA earlier.

**C.** An independent system for concurrent monitoring and evaluation of the works implemented in Tripura utilizing the funds available was evolved and implemented to ensure effective and proper utilization of funds. Accordingly, district wise Monitoring & Evaluation Committees were formed for each Forest District under Tripura State headed by the Conservator of Forests (M & E). The other members of this committees are - (i) District Forest Officer of the respective districts, (ii) Deputy Conservator of Forests (Working Plan) Division, (iii) DCF/ACF (CAMPA) (Member Secretary) & (iv) Informatics Research Officer, FHQ (GIS Lab). (The copies of the Memoranda on constitution of the said committees are enclosed herewith for perusal.)

The afore-mentioned district wise committees were formed in the year 2024. The committees have started the monitoring and evaluation exercise in the fields and yet to submit the report(s). As soon as the report is received, will be sent to the NA immediately.

**D.** There is also a practice of conducting Monitoring and Evaluation by a third party by an agency namely "Centre for Forest – Based Livelihoods and Extension (CFLE) (A Unit of Rain Forest Research Institute) Indian Council of Forestry Research & Education" which was selected by floating tender. The CFLE has conducted Monitoring and Evaluation of various activities by camping in field as well as verifying the office records up to the year 2021-22. (The third party monitoring reports of different activities taken up under Tripura CAMPA up to the year 2020-21 were sent to the National Authority vide this office No. F. 6-419/CAMPA-4/For-2022-23/(APO)/Part-I/4685 dated, 24-01-2023 which was e-mailed to the NA on 24-01-2023)

The monitoring and assessment report, as submitted by the third party (CFLE), is for the performance evaluation of implementation of CAMPA activities in Tripura undertaken by Tripura CAMPA for a particular financial year with the following objectives:

- i. Performance evaluation of implementation of CAMPA activities in Tripura implemented during a financial year.
- ii. Development of key performance indicators and finalization of the same in consultation with Tripura CAMPA authority.
- iii. Data collection and collation.
- iv. Carrying out comprehensive outcome focused impact evaluation of the schemes.

**Methodologies Adopted for Evaluation by the Third Party (CFLE) are as follows -**

**1. Generation of format to collect information on various assessment parameters:**

With reference to the evaluation objectives, the evaluation formats are prepared separately for evaluation of different works depicting the point wise description of observations, remarks, grading and all the relevant parameters related to the following CAMPA activities:

i. Plantations

- Compensatory Afforestation - CA (Old & New)
- AR / ANR plantations under NPV Component & other plantations.

ii. Nursery

- School Nursery
- Departmental Nursery

iii. Construction

- Chain link wire mesh fencing
- Barbed wire fencing
- Staff Quarter (Up to the Forest Range Officer)
- FG Twin Barrack
- Strong Room
- Construction for Forest protection Unit



- Office-cum-Residence (Up to the Forest Range Officer)
- Water holes & check dams, etc.

## **2. Interaction with field staff and data collected from the field**

During field visit in most of the cases, along with the evaluation team the official of the Forest Dept. are also consulted with and referred (Mostly SDFO, Forest Range Officer, Forest Beat Officer and Forest Guards).

## **3. Interaction with communities wherever applicable**

The issues related with the CAMPA plantation/developmental works are noted in details through interaction with the local communities on various aspects .Some of them are:-

- The benefits and problems related with the project work are gathered.
- Jhum cultivation and it' s damaging effect to plantation

## **4. Sub-Division wise CAMPA Activities and Evaluation**

Achievements against various objectives as set in the approved Annual Plan of Operation (APO) which are in progress and/or completed in each of the Forest Sub-divisions are evaluated for performance. The new administrative set up of Forest Districts in Tripura which includes 17 nos. of Forest Sub-divisions and 4 ( four) nos. of Wildlife Sanctuaries is followed for the field evaluation of different activities undertaken under Tripura CAMPA.
