Sir/ Madam,

As you are already aware that the Section 4(5) of the Compensatory Afforestation Fund Act, 2016 provides that, the monies received in the State Fund shall be an interest-bearing fund under the Public Accounts, Also, the Section 4(6) states that the balance in each State Fund shall be non-lapsable and generate interest as per the rate declared by the Central Government on yearto-year basis.

- It is noticed that the annual interest upto 31.03.2023 accrued on the State CAMPA funds available in the Public Accounts of your State has not been credited.
- Further, the applicable rate of interest on Compensatory Afforestation Fund Deposits kept in the Public Accounts is fixed at 3.35% p.a for the financial year 2023-24 as communicated by the Budget Division, Department of Economic Affairs, Ministry of Finance [copy enclosed]

It is, therefore, requested to kindly look into the matter for crediting of the annual interest on State CAMPA funds deposited in Public Accounts of the State upto 31.03.2024 at the earliest.
